- Fuller Road Guardrail: South side of Fuller, near east entrance to Huron High. Replacement of guardrail in poor condition. Work will be scheduled for 2018.*
- Seventh Street Buffered Bike Lanes: Installation of buffered bike lanes. Work will be scheduled for Spring of 2018.*

**1.     Sarah Byers - Deer Sterilization (AC-1)**

*Sarah Byers, Ward 1 resident and member of FAAWN, spoke about the sterilized deer and questioned why some deer have collars and some are only tagged. She noted it is not possible for the sharpshooters to have determined who is the matriarch of the herd.*

**2. Lisa Abrams - Deer Cull (AC-1)**

*Lisa Abrams, Ward 2, spoke about the City Administrator's deer management report. She urged staff to collaborate with members of FAAWN to discuss the goals identified in the report. She requested a moratorium on the cull for 2018 until the outcomes of the current cull efforts could be analyzed.*

**3. Roger Kuhlman - Congress Legitimately Makes U.S. Immigration Laws, Ann Arbor City Council Does Not**

*Roger Kuhlman, 2421 Placid Way, spoke about U.S. Immigration laws and stated the Ann Arbor City Council has no authority to make its own immigration laws. He urged Council to address with the U.S. Congress any issues they have with these laws.*

**4. Dennis Lollar - Gasoline Powered Leaf Blowers**

*Dennis Lollar, 688 Peninsula, spoke in opposition to gasoline-powered trimmers and mowers, stating the two-cycle engines used in these types of tools contribute to noise and air pollution. He urged Council to mandate that landscapers move to battery powered equipment.*

**5. Jane Klingsten - Co-Compliance in Water Resources and Accessibility**

*Jane Klingsten, representing Northside neighbors, spoke about enforcement of City Codes and planning issues. She objected to the return of a site plan to Council and the process that brought the site plan back. She urged staff to work with legal counsel on these issues. She also spoke about ADA issues in planning.*

**CC COMMUNICATIONS FROM COUNCIL**

**COUNCILMEMBER ACKERMAN**

*Councilmember Ackerman spoke about AC-2, the Administrator's Response to R-17-020, Street Level Uses Downtown. He noted that the Planning Commission is recommending several changes to be reviewed at City Council; all regulations promote retail on the first floor.*

**COUNCILMEMBER SMITH**

*Councilmember Smith introduced CC-1, a nomination to appoint Veronica Hannah to the Environmental Commission. Councilmember Smith stated Ms. Hannah's appointment would be confirmed at a future meeting, noting that the current vacancy is due to Councilmember Frenzel's appointment to City Council.*

**COUNCILMEMBER KRAPOHL**

*Councilmember Krapohl announced the next meeting regarding the Packard Square development update, to be held at Cobblestone Farm on Wednesday at 6p.m.*

**COUNCILMEMBER WARPEHOSKI**

*Councilmember Warpehoski spoke about his promise to bring an enforcement resolution regarding immigration issues. He stated the resolution would be ready for the April 17 Council meeting. Councilmember Warpehoski stated it has been very positive working with staff on this issue.*

**COUNCILMEMBER LUMM**

*Councilmember Lumm stated the Library Lot, and CORE Spaces development project item will be on the April 17 Council agenda, noting that there is not a public hearing on the item. She stated there has been a request to postpone action on this item until the audit on the bonds has been completed.*

*Councilmember Lumm asked the City Administrator for an update regarding the train station environmental assessment. (Eli Cooper, Transportation Manager, provided an update.)*

**COUNCILMEMBER EATON**

*Councilmember Eaton noted that the Packard Square meeting at Cobblestone Farm would be recorded and replayed by CTN.*

**COUNCILMEMBER GRAND**

*Councilmember Grand thanked the Muslim community for their welcoming open house last Sunday.*

**COUNCILMEMBER WESTPHAL**

*Councilmember Westphal spoke about AC-2. He thanked Planning Commission for their work on this issue. He stated he was glad to see that Planning Commission is tackling the issue of building materials.*

**COUNCILMEMBER LUMM**

*Councilmember Lumm thanked the Mayor for his proclamation recognizing the Boy Scout Troop 4, the longest serving troop in Michigan. She stated this troop has met at First United Methodist Church for 100 years and a plaque has been mounted on the church in their honor.*
