CALL TO ORDER

Mayor Hieftje called the meeting to order at 7:10 p.m. in the Guy C. Larcom Jr., Municipal Building, 2nd Floor Council Chambers, 100 N. Fifth Avenue.

MOMENT OF SILENCE

Council stood for a moment of silence.

PLEDGE OF ALLEGIANCE

Mayor Hieftje led Council in the recitation of the Pledge of Allegiance.

COMMUNICATIONS FROM COUNCIL**COUNCILMEMBER TAYLOR**

Councilmember Taylor updated Council on the status of the Mutually Beneficial Committee with the DDA. He stated the parcel-by-parcel plan is nearly ready for Council consideration. An H-item, H-7 from the Committee, is part of the Council packet this evening. H-7 is an announcement and the expectation is that the plan will come to Council on January 18, 2011.

COUNCILMEMBER SMITH

Councilmember Smith stated she attended the most recent Human Rights Commission meeting. The Commission discussed equality in marriage and also saw a presentation from UM students regarding privacy issues. Her participation on the committee is the first for a councilmember in a number of years.

Councilmember Smith announced that the US Senate repealed "Don't Ask, Don't Tell" for the military and it is ready for the President's signature.

COUNCILMEMBER ANGLIN

Councilmember Anglin expressed concerns about a statement regarding the DDA sheltering the Council from the public. He stated this is not the case and the public is welcome to contact Council even in a circumstance related to the downtown.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR**CHROMIUM 6 ARTICLE ON ANNARBOR.COM**

City Administrator Roger Fraser updated Council and the public regarding an article on AnnArbor.com indicating that a national environmental watch group issued a study suggesting that the City of Ann Arbor has high levels of Chromium-6 in the drinking water. The following report by the City's Water Treatment Manager was read by Mr. Fraser:

Today the Environmental Working Group (EWG), a non-profit environmental group, released results of a study they completed on the occurrence of hexavalent chromium (also known as "Chromium-6"). Hexavalent chromium is not a regulated contaminant, but is being considered for regulation by the state of California. EWG reportedly analyzed drinking water from 35 cities nationwide, and detected hexavalent chromium in 31 of those cities, including Ann Arbor. The study reports hexavalent chromium in Ann Arbor at 0.21 parts per billion.

Total chromium, which includes hexavalent and trivalent forms of chromium, is a regulated contaminant under the Safe Drinking Water Act. The maximum allowable level of total chromium in the finished drinking water is 100 parts per billion. The City is required to test its finished water for total chromium every 9 years. However, the City tests the water for chromium on an annual basis. Results from the last three annual samples were less than the EPA-approved minimum detection limit (currently set at 2 parts per billion). Samples below the minimum detection limit are considered "non-detected".

If the City detected total chromium, follow-up samples would be taken to determine the levels of hexavalent and trivalent chromium.

The City was not contacted by EWG to participate in the study or to supply a water sample. It is unknown where EWG collected the water sample(s).

While hexavalent chromium can come from man-made sources, it can also be naturally occurring at low levels.

BUDGET WORKING SESSIONS

Mr. Fraser suggested that the Council consider the following dates for budget working sessions in January and February:

PARKS AND RECREATION

Mr. Fraser announced that the parks facilities are open over the holidays and encouraged folks to come out and visit the parks. He also stated that the golf courses are closed for the season, but noted that the 2010 season had one of the highest seasons for rounds of golf at both Huron Hills and Leslie Park Golf Courses.

PEPSI REFRESH GRANT

Mr. Fraser reminded the public that the organizers of the Ann Arbor Skate Park are competing for a Pepsi Refresh Grant. Supporters can vote for the project once per day in the month of December. Currently, the skate park proposal is 20th nationally.

CHRISTMAS TREES

Mr. Fraser reminded Council and the public that Christmas trees are no longer collected curbside for recycling. He stated residents have several options for disposal of Christmas trees; they can be dropped off at the drop-off station on Ellsworth until January 31 or saved for bundled compost collection in the Spring.

CITY HALL HOLIDAY SCHEDULE

Mr. Fraser announced that City Hall would be closed for the Christmas holiday on Friday, December 24 and from 12:00 p.m. to 5:00 p.m. on Thursday, December 23. The closure would not affect trash and recycling collection. The same Thursday, Friday closure schedule would apply the following week for the New Year's holiday; trash collection would also not be affected that week either.

A public hearing was conducted on the proposed Ordinance to Amend Section 10.1a of Chapter 126, Traffic (Adoption of Motor Vehicle Code and Uniform Traffic Code), of Title X of the Code of the City of Ann Arbor (Ordinance NO. ORD-10-39). Notice of

public hearing was published December 16, 2010.

Charles Loucks, 2957 Leslie Park Circle, spoke in favor of the proposed ordinance, stating he had successfully fought a ticket with the City of Ann Arbor after it was issued not in compliance with the Motor Vehicle Code.

Jim Walker, of the National Motorists Association, spoke in support of the proposed ordinance. He stated the 85th percentile is needed for setting speed limits.

A teacher and Safe Schools representative from Clague Middle School expressed concern about increasing the speed limit on Nixon Road near Clague Middle School.

Erica Briggs of the Washtenaw Bicycling and Walking Coalition spoke in opposition to the proposed ordinance. She stated the WBWC has always supported local control of speed limits. She urged Council to continue to work with the Michigan Municipal League on this issue.

Bruce Geffen, a teacher at Clague Middle School, expressed concern with the proposed ordinance and the effects it will have on the Nixon Road crosswalk that is utilized by young students.

Karen Morehead of the Washtenaw Bicycling and Walking Coalition expressed concern about a speed limit increase on Nixon Road near Clague Middle School.

Tom Wieder spoke in support.

David Sponseller spoke in support.

There being no further comment, the Mayor declared the hearing closed.

THE CITY'S ADOPTION BY REFERENCE OF THE UTC DOES NOT SIMULTANEOUSLY PROHIBIT THE EXISTENCE, ADDITION, AND ADOPTION OF FURTHER ORDINANCES OR REGULATIONS, PROVIDED SUCH ORDINANCES OR REGULATIONS DO NOT CONFLICT WITH STATE LAW.
