*Mayor Hieftje called the meeting to order at 7:05 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron St.*

- 1. Thomas Partridge - What would Jesus advocate? Improve public funding for transportation, healthcare, housing and drug prevention; or pursue selfish private interests? (DC-1)**

*Thomas Partridge, City resident, spoke in opposition to medical marijuana. He asked what Jesus would advocate for, including healthcare, affordable housing and transportation.*

**2. Henry Herskovitz - AAPD (DS-3 and DS-4)**

*Henry Herskovitz, 404 Mark Hannah, spoke about several complaints he made to the Ann Arbor Police Department. He stated that on both occasions, the AAPD handled the case well, but the City and County prosecutors failed to prosecute. He questioned the motivation behind the prosecutors' refusals to prosecute his cases that involved thefts of property at peaceful pro-Palestine rallies.*

**3. Luis Vasquez - Medical Marijuana (DC-1)**

*Luis Vasquez spoke in support of medical marijuana and urged the City Attorney not to act against the will of the voters.*

**4. Jamie Lowell - Michigan Association of Compassion Center; Medical Marijuana (DC-1)**

*Jamie Lowell, an advocate for medical marijuana, urged Council not to act on changing existing local ordinances regarding medical marijuana until the Supreme Court ruling was issued.*

**5. Nancy Wright Maxwell - Medical Marijuana (DC-1)**

*Nancy Wright Maxwell spoke in support of medical marijuana.*

**6. Mitchell Elkiss - Dispensaries (DC-1)**

*Mitchell Elkiss, a medical professional, spoke in support of marijuana dispensaries. He stated access to medical marijuana is needed.*

**7. Laurel Hufano - Dispensaries (DC-1)**

*Laurel Hufano, a medical marijuana patient, stated she needs medical marijuana for her medical care.*

*Drew Driver spoke in support of medical marijuana.*

**COMMUNICATIONS FROM COUNCIL***COUNCILMEMBER DEREZINSKI*

*Councilmember Derezinski stated the City recently won two lawsuits; the HDC redevelopment of the old YMCA site and a case involving alleged police use of force. He also noted that the City Attorney, Stephen Postema, was recently recognized by the MML for his distinguished service.*

*COUNCILMEMBER SMITH*

*Councilmember Smith updated Council on the completion of the public survey regarding the "Connecting William Street" project. She said over 2000 responses were received and results indicate that residents want a vibrant downtown sidewalk experience. She also noted there is support for businesses in the area.*

*COUNCILMEMBER ANGLIN*

*Councilmember Anglin requested more information and clarification regarding Fuller Road Park. He stated that citizens want answers regarding monies being spent on this project. Councilmember Anglin stated there has been little public input on this project, noting that the sewer interceptor project is actually phase 1 of this project and the public has a right to know.*

*COUNCILMEMBER BRIERE*

*Councilmember Briere stated the Environmental Commission is working on renewing their goals.*

*COUNCILMEMBER TAYLOR*

*Councilmember Taylor updated Council on PAC. He stated several public meetings have been scheduled regarding the Parks Millage renewal. Upcoming meetings are as follows (all are at 6:30 p.m.):*

*Councilmember Taylor also reminded Council and the public that the City is hosting a golf scramble at Leslie Park Golf Course on Good Friday. It is a noon shotgun start for 18 teams of four golfers each.*

*COUNCILMEMBER LUMM*

*Councilmember Lumm thanked Councilmember Smith for her report on the William Street project. Councilmember Lumm noted that a land-use economist from Philadelphia, PA is currently meeting with the DDA.*

**COUNCILMEMBER KUNSELMAN**

*Councilmember Kunselman stated the Taxicab Board currently has two vacancies. He urged interested residents to contact the Mayor's Office to apply.*

**MAYOR HIEFTJE**

*Mayor Hieftje noted that he is reading a copy of the book, "Economies of Place." He urged others to read their copies. Mayor Hieftje also commented regarding Councilmember Anglin's comments about Fuller Road. The mayor noted that the sanitary sewer project would be necessary regardless of whether the Fuller Road Station project moves forward. He said it is very common for sewer replacement to occur at the same time as other street repair work.*

**COMMUNICATIONS FROM THE CITY ADMINISTRATOR****SAFETY SERVICES HIRING UPDATE**

*City Administrator Steve Powers updated Council on the status of hiring within the Police and Fire Departments. He stated five new hires are starting with the AAPD on April 16. Mr. Powers noted that information would not be available regarding Fire Department hires until after the approval of the upcoming fiscal year budget.*

**UM FOOTBALL SCRIMMAGE**

*Mr. Powers reminded Council and the public about the upcoming UM football scrimmage game on April 14 at noon. He stated the same parking restrictions would be in effect as what is enforced on football Saturdays in the Fall.
