Hello Suzann and Members of the Ann Arbor Transportation Commission,

Thank you for your note and service to the City. My wife Kate and I are happy to hear that the City of Ann Arbor Transportation Commission is taking up this important safety issue. We are also grateful for the support of our Ward 2 representatives Kathy Griswold and Linh Song and engagement of the police and Mayor.

We hope that prompt action is taken this fall to remedy the situation. One question—is it helpful for my wife and I to participate in the meeting? I ask because we will be out of town on September 21st. Of course we are very committed to this issue and pedestrian safety, and we are also happy to reach out to the parents of the child who was killed and other neighbors who share our concerns. Please let us know how we may best provide input to the Commission if we are not available on September 21 (for example, if the discussion item should be rescheduled).

In addition, recently trees have been planted by the City in the right-of-way in front of our neighbors home (2045 Geddes) that completely obscure our view of traffic when we are attempting to pull out of our driveway onto Geddes. Please see attached photo, taken looking East from our driveway—it is easy to see how the trees block the view of oncoming traffic. This has resulted in several near-miss accidents, particularly with cars traveling at high speed westbound on Geddes. Thank you for considering this issue as well in your planning.

Dear Ann Arbor City Leaders,

I am writing to check the status in follow up on our email conversation from July. Cars continue to race down Geddes, often passing cars that are going the 25 mph speed limit (it has happened to me twice in the past month). Pedestrians continue to cross regularly at the intersection of Onondaga and Geddes. Multiple neighbors have expressed interest in a crosswalk being included at the intersection when updates are done in the fall and some speed controlling methods.

Please let us know what we can do further to move things forward. Kate and I would be happy to schedule an appointment with City Supervisor Milton Dohoney, if that would be helpful.

Good morning Council Member Briggs,

Thank you for your voicemail message and for your engagement. I had a bit of difficulty following your message, as the audio was a bit garbled. My understanding of it is that the transportation commission and staff are the way to move the concerns forward to resolution, but there may be some hesitancy or bureaucracy that delay action. I'm sure we all agree that a child's death in the past and a recent hit-and-run injury to a child at the same intersection make clear that this issue is a pressing one for the City.

My wife and I are happy to provide input in the transportation commission meeting and/or to work with Chair Kleinman directly, whichever is most helpful to resolve the issue. With Ann Arbor's emphasis on pedestrian safety (e.g. Healthy Streets and Vision Zero), promptly addressing this known danger is most consistent with our values. We were not able to locate contact information for Chair Kleinman on the Ann Arbor website, so we are not certain if she is aware of the concern.

We did receive a response from PSS Opsahl in the Ann Arbor Police Department (attached) which stated that they will conduct extra traffic enforcement in the area, and forwarded our concerns to traffic engineering. We hope that the many parties involved in this issue can work together to make Geddes safe for pedestrians, especially children. We did not see signs of increased enforcement over the weekend, but it may take some time to get that in place.

Thank you again Council Member Briggs, and all of you for your engagement and service. Please let us know how we can best see this issue through to resolution.

Dear Council Member Song and Mayor Taylor,

I hope that you had a nice trip, Ms. Song. Thank you both for your responses. Sorry that I missed Ms. Song's call—I was in a meeting when you called. Kate and I are grateful to you for your help and that of Council Member Griswold and Mayor Taylor.

We are glad to hear that some work is being done on Geddes. For clarity, the area of concern is the region circled on the attached map below. It is a different area

from the Racquet Club. We are aware that work is planned on our region of Geddes which, in addition to the hit-and-run on the little boy, is why we are reaching out now with such urgency.

When the work is being done, a crosswalk could be placed on the East side of Onondaga, across Geddes (see aerial view). We recognize that visibility and high speeds are an issue (that is how the first child (Annie) was killed at this intersection and also how the young boy was recently hit). Therefore, in addition to the crosswalk, we believe that it would be necessary to place flanking speed humps or speed tables. I've drawn on aerial view to show what we mean by this.

In addition to these measures, there are very few 25 MPH signs on Geddes Avenue. Placing more speed limit signs and encouraging the police to ticket frequently could do much to increase traffic safety, particularly for our children.

None of these interventions would involve major incremental cost. It is sad to think that Annie's life could have been likely saved for a tenth the cost of the hospitalization prior to her death.

Mayor Taylor, Kate and I have filled out the AAPD make-a-suggestion in the past, and have done so again, including this email chain. I've cc'ed the transportation commission (this is the instruction on the website you shared). Together with your efforts, we hope that Molly Kleinman is alerted to the issue in time for the July 20th meeting. I would be happy to speak with any of you by phone or to join a zoom meeting.

It does not address speed or traffic calming but that addition is one improvement supporting pedestrian safety that I'm eager to see happen.

I will work with CM Briggs and Transportation Commission Chair Molly Kleinman to explore what our traffic calming options are for Geddes. I'm happy to organize a Zoom call once we have some ideas to present back to your family and residents. Thank you again for reaching out.

Dear Mayor Taylor,

My wife Kate and I live at 2037 Geddes Avenue. After speaking to our local Council Member, we are writing to request that the issue of pedestrian accidents, crosswalks, and traffic speeds on Geddes Avenue be raised with the Transportation Commission. As shared in the emails below, one child was killed and another injured on Geddes in front of our home (intersection of Onondaga and Geddes Avenue).

For your convenience, I have attached a photo of the intersection, looking North (towards our home). This is a location that many are forced to cross Geddes, as there is no sidewalk on the South side of Geddes to the East of this intersection (right side of photo). In addition, many park in this area or walk their animals. In any hour, several people are crossing. At the same time, traffic routinely goes 40-50 MPH (including trucks) in a 25 MPH zone. In fact, when we drive 25 on Geddes Avenue, we are routinely passed by aggressive drivers crossing the double yellow lines. I have yet to see police give a citations in this area.

The numbers of racing cars/trucks and close-calls we witness from our home are horrifying. The latter child that was hit (which Kate describes below) was a hit-and-run, leaving a young child thrown to the pavement.

We understand that road repairs and upgrades are planned soon on Geddes in this location and we urge you to include speed bumps/traffic controls and a well-marked crosswalk in those plans.

Something must be done to prevent more children from being hurt.
