PROPOSED CITY PLANNING COMMISSION MOTION

The Ann Arbor City Planning Commission hereby recommends that the Mayor and City Council approve the Desprez Annexation and R1A (Single-Family Dwelling District) Zoning.

STAFF RECOMMENDATION

Staff recommends this petition be **approved** because the property is within the City's water and sewage service area and the proposed R1A zoning is consistent with the adjacent zoning, surrounding land uses and the adopted <u>Northeast Area Plan</u>.

LOCATION

This site is located on the south side of East Huron River Drive west of Blake Way (Northeast Area). This site is in the Huron River Watershed.

DESCRIPTION OF PETITION

The petitioner requests annexation of a one-acre site from Ann Arbor Township and zoning to R1A single-family residential zoning designation. The petitioner wants to connect the existing home to City water and sewer.
