**INT INTRODUCTIONS****INT-1 [11-1236](#) Introduction of ICMA Fellows**

*Wendy Rampson, Planning Manager, introduced members of the International City/County Management Association (ICMA) Fellows Program. Earlier this year, the City was selected by the ICMA as a host community for the International Professional Fellows Program. The program is an exchange program designed to increase mutual understanding between the people of the United States and residents of other countries to promote more sustainable communities worldwide. The ICMA Program is paid for through the support of the Department of State Educational and Cultural Affairs. Ms. Rampson introduced the Ann Arbor Fellows from Indonesia who are visiting for two weeks. All fellows in the program are selected to visit particular cities because of their similar sizes and issues in their home cities.*

**1. Rita Mitchell - Grant of Easement to DTE Energy (MichCon) (DS-4)**

*Rita Mitchell, 621 Fifth St., addressed Council regarding the Resolution to grant an easement to DTE Energy MichCon. She said that the resolution was provided, however, there was no documentation of the language or the agreement that is proposed to be approved between the City and DTE Energy. The context for the change was not provided to the public, she stated. Ms. Mitchell urged Council to postpone the resolution and review the process.*

**2. Dennis Hayes - Clark Rezoning, 1712 S. State St. (C-1)**

*Dennis Hayes, 120 N. Fourth Ave., said that Tree City Cooperative has been attempting to comply with numerous requests by the City regarding their facility. He stated he understands that a medical marijuana dispensary is not part of the City's master plan in this location, but stated he thinks it is an appropriate use for the area and is a suitable location for that purpose. He expressed concern that the City Attorney is adopting the State Attorney General's opinion and the City has been demanding information from medical marijuana dispensaries based upon the recent Court of Appeals ruling. He urged Council to approve this rezoning and to be flexible.*

**3. Thomas Partridge - Recall Republicans in government. Protect Michigan's most vulnerable. Require affordable housing in all neighborhoods and developments in Ann Arbor, including City Place Apartments (DC-2)**

*Thomas Partridge, Ann Arbor resident, addressed Council urging the recall of Republicans in government, protecting Michigan's most vulnerable citizens, and requiring affordable housing in all neighborhoods and developments in Ann Arbor, including City Place Apartments.*

**4. Kermit Schlansker - Finance**

*Kermit Schlansker, 2960 Marshall, said that a league of local government partners comprised of city, county and state government officials could easily finance pilot projects dealing with the energy needs of local communities. Progress would no longer be dependent on the uncertainties of national politics, he stated.*

**5. Henry Herskovitz - Israel's legitimacy questioned?**

*Henry Herskovitz, 404 Mark Hannah, addressed Council regarding the issue of fairness. He said that the City of Ann Arbor has an ideal of fairness. He stated this same ideal of fairness, whether it be for local issues, such as neighborhood issues, or fairness between Israel and Palestine should be considered.*

**6. Libby Hunter - Fuller Park**

*Libby Hunter, 827 Bruce, serenaded Council in opposition to the Fuller Park Station Project.*

## **COMMUNICATIONS FROM COUNCIL**

### **COUNCILMEMBER ANGLIN**

*Councilmember Anglin read an email regarding Fuller Road Park and the proposed Fuller Road Station into the record, which read as follows:*

*"I strongly oppose any plans for Fuller Road without a public referendum. I understand that the current plans for the building, a parking garage, are in the form of a lease and this gives the appearance of a way to circumvent the requirements that changes and sales of city parkland require a public referendum. If so, this seems against the spirit of the public referendum requirement. If it is not meant to circumvent the spirit of that, then having a referendum even in the case of this lease proposal, would be the best and most transparent way to abide by the spirit of that requirement and Ann Arbor's dedication to its parks, even if it is not strictly required, would abide by the spirit."*

*Councilmember Anglin said that due to his concerns and the large number of questions received from residents, the Council should continue to have a discussion publicly on this issue. He asked the city clerk to add comments he provided as part of the Clerk's Report of Communications.*

### **MAYOR HIEFTJE**

*Mayor Hieftje talked about the paved parking lot across the street from Fuller Park Pool and the soccer complex. The mayor stated that the federal government has awarded the first phase of funding for the Fuller Road Train Station and that money has now been obligated. The first \$2.8 million is now guaranteed, in addition to financial support that is coming from the State to fund high-speed rail between Detroit and Kalamazoo.*

*Councilmember Teall announced that a dedication would take place on October 4, 2011 at 7:00 p.m. for the Dreiseitl Stormwater Art Project at City Hall.*

*The collaborative efforts of the City of Ann Arbor, the Ann Arbor Transportation Authority, the Downtown Development Authority and the University of Michigan on future transit options will be showcased at the City Council Work Session on October 10, 2011 in a presentation of the Ann Arbor Connector Feasibility Study. The study concluded that Ann Arbor has all of the attributes necessary for an advanced transit technology such as light rail or bus rapid transit system to complement the existing bus transit system. The presentation by URS Corporation, a national consulting firm hired by the partnership, will highlight the study's assumptions and recommendations for next steps.*

He stated the resolution should have specific language directed toward improving energy conservation and reducing energy costs for people in multiple-housing developments including cooperatives, condominiums and traditional apartments in the city.*

*Conan Smith, 234 8th St., Chair of the Washtenaw County Board of Commissioners, spoke in support of the PACE program and thanked Council for taking the lead on this program. Commissioner Smith stated the County would like to use the work that the City is doing to encourage businesses to improve their energy efficiency and try and replicate that program in some of the County's smaller communities.*
