SEMCOG reports results of vehicle emissions testing program

SEMCOG has just released the findings of its roadside emissions testing program conducted on random vehicles throughout Southeast Michigan last summer:

- Approximately two percent of the passenger vehicles operating in Southeast Michigan were high emitters. This is less than reported in several other metropolitan areas around the country.
- Southeast Michigan has fewer high emitters because its vehicle fleet is younger.
- This project confirmed that a small fraction of vehicles account for a major portion of emissions. Ten percent of the vehicles accounted for roughly 70 percent of the total pollutant emissions from passenger vehicles.
- Many owners of high emitters assumed their emissions were high simply because their vehicle was old. However, in reality, these vehicles emit far more pollution than a properly operating vehicle of the same age.
- Voluntary efforts to reduce vehicle emissions were met with a high degree of acceptance. Very few negative comments were received and a significant percentage of owners reported taking their vehicles in for repairs.

These results tell us that there are two targets of opportunity for reducing emissions from motor vehicles:

- Reduce emissions from existing high emitters.
- Educate the public to prevent vehicles from becoming high emitters in the first place.

Once again, the U.S. Environmental Protection Agency proposes lowering the ozone standard. State and local governments will have to find ways to reduce overall emissions in order to attain the new standard. However, in light of this project's results, SEMCOG believes that mandatory emissions testing would be an inefficient use of scarce fiscal resources (since nearly every vehicle will soon have on-board emissions detecting equipment). Resources should be focused on incrementally reducing the number of high emitters and preventing high emitter occurrence.

New HOV lane, express bus service begin today

SEMCOG worked with the Michigan Department of Transportation (MDOT) and transit providers — SMART and DDOT - in developing the idea of putting Michigan's first HOV (high occupancy vehicle) traffic lane in each direction on a 5.25-mile stretch of Michigan Avenue from Wyoming Avenue to Detroit's Central Business district for use by buses and cars/vans with two or more occupants. SEMCOG provided data and assisted MDOT in analyzing various ways to alleviate congestion during the Ambassador Bridge Gateway construction project, the major project that closes a section of I-75 from Rosa Parks Boulevard to Clark Street in Southwest Detroit for 22 months. Another viable option for commuters traveling from Downriver communities to Downtown Detroit during this construction is the DDOT/SMART "Gateway Express" service on the HOV lanes. SMART and DDOT have formed a historic partnership to operate a new commuter bus service. At the February 15 press conference announcing these initiatives, MDOT Director Kirk Steudle said, "This is an important partnership for transit in Metro Detroit. We commend DDOT and SMART for coming together to make this possible. We hope it represents the first of many partnerships involving MDOT, DDOT, and SMART." Phase II Stormwater Permit extended

SEMCOG continues to work on behalf of our members, facilitating a workgroup that is providing comments to the Michigan Department of Environmental Quality (MDEQ) on the new draft chase II stormwater permit. The current permit

expires on April 1, 2008. With significant progress being made, but additional talks needed, MDEQ has agreed to extend the current permit coverage. In order to have the current permit extended, permittees will need to fill out an abbreviated permit application by March 31, 2008. MDEQ will send a letter with this permit application to all permittees in the next couple of weeks.
