## Street Reconstruction Millage Renewal - Proposed Public Engagement Process

*Homayoon Pirooz, Project Management Manager, gave a presentation on the Street Reconstruction Millage renewal proposed Public Engagement Process to Council. The City of Ann Arbor's Street Reconstruction Millage ("Street Millage") will expire at the end of 2011. Since the 1980s, the Street Millage has provided critical funding - and the ability to leverage matching federal and state dollars - to ensure the quality of Ann Arbor streets. City staff intend to recommend that City Council consider ballot language on August 4th that would authorize the placement of a Street Millage on the November 8th ballot.*

- 1. Thomas Partridge - Build affordable housing not marijuana drug houses. Increase funding for human services. Recall Governor Snyder and the republican legislative leadership.**

*Thomas Partridge, Ann Arbor resident, addressed Council regarding building affordable housing, not marijuana drug houses. He also urged Council to increase funding for human services and to support recall efforts for Governor Snyder.*

- 2. Tony Keene - Medical Marijuana (B-2)**

*Tony Keene, 240 Crest, spoke in support of the proposed Medical Marijuana Ordinances and thanked Council for taking the time to get it right. He said that it is a well defined and structured ordinance.*

- 3. James D'Amour - Professional Services Agreements with Perimeter Engineering, LLC (DS-7 and H-1)**

*James D'Amour, 2771 Maplewood, expressed concern with the Resolution approving the Professional Services Agreement with Perimeter Engineering, LLC and the Fuller Road Station. Mr. D'Amour also addressed Council regarding the Ann Arbor Public Art Commission 2011 and 2012 Public Art Plans.*

- 4. Charles Ream - Medical Marijuana (B-2)**

*Charles Ream, 1818 Packard, expressed concerns with the proposed Medical Marijuana Ordinances and asked that portions of the ordinance relating to cultivation facilities and zoning compliance permits be removed. He also suggested that the Marijuana Zoning and the Marijuana Licensing ordinances have similar titles.*

- 5. Rhory Gould - Medical Marijuana (B-2)**

*Rhory Gould, 5537 Overbrook, addressed Council regarding the proposed Medical Marijuana Ordinance. He thanked Council for all of their hard work on the ordinance and expressed concern regarding the moratorium on the opening of new*

*dispensaries. He said that it is time to do what's right by passing an ordinance that protects patients, caregivers and dispensaries and allows safe operations in the City.*

**6. Barbara Bach - Fuller Road Station**

*Barbara Bach, 2061 Dave St., addressed Council regarding the Fuller Road Transit Station Project. She said that the parking structure is getting in the way of a reasonable community discussion about rail; whether it is high-speed or commuter; park preservation and protection of parks legally. She spoke in opposition of the Fuller Road Station and urged Council to make plans to preserve the parkland and cancel the project.*

**7. Nancy Shiffler - Fuller Road Station**

*Nancy Shiffler, 2877 Sorrento Ave., chair of Huron Valley group of the Sierra Club, expressed concern with a precedent being set with the Fuller Road Station project. She said that this would have long term implications for all parks in Ann Arbor. The land proposed for the Fuller Road Station has been used as parkland for more than 80 years and is currently identified in the City's master plan as parkland and is designated in the PROS plan as part of Fuller Park.*

**8. Henry Herskovitz - City Elections**

*Henry Herskovitz, 404 Mark Hannah Place, addressed Council regarding a concern with a candidate on the August 2, 2011 City Primary Election, Mr. Neal Elyakin. Mr. Herskovitz expressed concern regarding Mr. Elyakin's allegiances to Israel.*

**9. George Gatson - Fuller Park**

*George Tatson, 1217 Island Dr. addressed Council regarding Fuller Park. He spoke in opposition to the Fuller Road Station Parking Structure as currently proposed on parkland.*

**10. Dennis Hayes - Medical Marijuana (B-2)**

*Dennis Hayes, 120 N. Fourth, asked that Council review Section 5:04 of the medical marijuana ordinance and find a way to require less record and information keeping for caregivers, patients and dispensaries. This information could be harmful to individuals in a possible federal case.*

**COMMUNICATIONS FROM COUNCIL**

**COUNCILMEMBER TEALL**

*Councilmember Teall reported that the Building Committee met to review the construction renovation budget for the Larcom building renovation. The project is on time and proceeding under budget, she stated.*

**COUNCILMEMBER SMITH**

*Councilmember Smith informed Council that on May 17, 2011, the Human Rights Commission held a special meeting at the Neutral Zone. The topic of the meeting was about anti-bullying. It was put on by the Riot Youth which is the LGBTQ Group at the Neutral Zone. The meeting was very informative.*

She also reported on the re-opening of West Park on June 19, 2011. A celebration recognizing all Ann Arbor volunteers will be held at the park on that day from 1-4 p.m.

#### COUNCILMEMBER ANGLIN

Councilmember Anglin updated Council on the PAC meeting of May 17, 2011. Eli Cooper gave a report on the Fuller Road Station project. Councilmember Anglin expressed concerns that the project is really looking more like a parking structure than anything else, and it was also a concern of many of the members of PAC. Mr. Anglin encouraged Council to watch the meeting.

#### COUNCILMEMBER BRIERE

Councilmember Briere asked that a work session of Council be scheduled to discuss Fuller Road Station in more detail.

#### MAYOR HIEFTJE

Mayor Hieftje said that a work session could be scheduled to discuss the Fuller Road Station project and added that \$196 million in federal funding is coming to Michigan for rail projects. This is the most exciting time for rail in Michigan in 100 years, the Mayor stated. This funding is in addition to the \$160 million that was previously announced. The mayor added that the plan has changed to put the train station inside of the main building.

#### COMMUNICATIONS FROM THE CITY ADMINISTRATOR

Interim City Administrator Tom Crawford reported on the following to Council:

#### FIRST AND WASHINGTON

Included in the agenda tonight is an item about the First & Washington project. For members of the community curious about the status of the project, the project is still moving ahead. The City expects the closing on the sale of the land to be some time in August or September of this year with construction activities to start sometime thereafter.

#### ARGO HEADRACE MODIFICATIONS PROJECT

The City has submitted the permit application to the State of Michigan and is currently waiting for the approved permit, prior to beginning any earthwork on the site. Mr. Crawford stated that the State has not given the City a timeline on their review and response, but six weeks is a reasonable guess.

*In order to expedite the work, the contractor will be mobilizing this month and beginning some preliminary clearing and preparation for construction. A permit is not needed to begin this preliminary work. At this point, Mr. Crawford stated, the City is still on track to meet the consent agreement deadline of November 15, 2011.*

#### *PROJECT MANAGEMENT*

*On May 26, the West Stadium (Suffolk to Hutchins) Improvements Project was awarded "Project of the Year – Transportation \$5 - \$10 Million" by the Michigan Chapter of the American Public Works Association. This award promotes excellence in the management and administration of public works projects.*

*The following streets are currently under construction as part of the 2011 Street Resurfacing Project:*

- Boardwalk/Victors Way – expected completion June 10*
- Spring St – expected completion June 10*
- Summit/Daniel ramps – expected completion June 10*
- Bruce St – expected completion June 25*
- Beakes St – Phase I expected completion early July. Phase II will begin following the Art Fair.*

*Construction on Green Road is expected to commence prior to the end of June.*

*Arbor Oaks water main installation continues on the Champagne branch of the neighborhood. Hemlock/Rockland/Plainview are scheduled to be paved late next week (weather permitting).*

#### *FIELD OPERATIONS*

*The weather has blessed us with a series of days without precipitation. However, the forecasts show chances of thunderstorms through the rest of the week. The recovery from the past month of heavy rainfall is continuing.*

*While the clean-up continues of the earth slide, Plymouth Road is open and the Ann Arbor Railroad has re-established service on its tracks parallel to Traver Road. Plans are being made to restore a nearby park with wetlands.*

*The rainfall on May 25 was significant, causing portions of the sanitary sewer system to be stressed. Currently, there are 87 reports of sewer back-ups into basements due to the heavy rain. Staff strived to investigate each location as the reports were received. When the staff could confirm that the sanitary sewer mains were stressed at a particular address, the property owners were given a referral to a catastrophe clean-up company. While the locations of the back-ups were scattered throughout the City, there was two clusters of occurrences near Packard and Stadium Blvd, and near Hill Street and Division.*

*Staff has met with the consulting engineer and construction manager for the Footing Drain Disconnection (FDD) program. A plan is being developed and will be brought forward to City Council near the end of summer. Items under consideration are creating new FDD program areas, possibly areas 6 & 7; accelerating the rate of disconnects, and treatment of sanitary manhole covers in flood plan areas.*

*Mowing of parks and public areas continue as much on schedule as weather allows. Portion of the parks are still too wet to support the mowers.*

**iv “Medical marijuana home occupation” means an accessory use of a nonresidential nature that is conducted by a registered primary caregiver who resides in the dwelling and (A) is performed within a single-family dwelling or within an accessory building to that single-family dwelling; (B) is for the purpose of assisting one or more registered qualifying patients WITH THE MEDICAL USE OF MARIJUANA who do not reside in the dwelling and (C) complies with the MMMA.**

(1) EXCEPT AS OTHERWISE PROVIDED FOR THE AMENDMENT OF EXISTING LICENSES, [N]no license issued under this chapter may be transferred or assigned, and no license is valid for any location other than the location specified in the license.

(2) A medical marijuana dispensary license issued by the City under this chapter, including the name and contact information for an authorized person and business manager(s), if any, shall be conspicuously posted in the medical marijuana dispensary where it is easily open to public view.

(3) Acceptance of a license from the City under this chapter constitutes consent by the licensee, owners, managers and employees to permit the city administrator or designee to conduct [routine] inspections of the licensed medical marijuana dispensary as required in section 7:506(7) to ensure compliance with this chapter.

7:504. Application Requirements for New Annual License or Renewal of Existing License; License Requirements for New License and for Renewed License

(1) Application [Acceptance]SUBMISSION. A medical marijuana dispensary that commenced operation prior to passage of the moratorium by City Council on August 5, 2010, shall have until sixty (60) days after the effective date of this chapter to submit an application for a new annual license. No other

applications will be accepted by the City until seventy-five (75) days after the effective date of this chapter. The medical marijuana dispensary may continue to operate pending final action on the application unless the Building Official determines that it must be closed for safety reasons. Within 60 days after an application is denied, the medical marijuana dispensary shall discontinue all operation unless the Building Official determines it must be closed sooner for safety reasons.

(2) **Application Requirements FOR NEW LICENSE.** An application for a new annual license [or the renewal of an existing license]for a medical marijuana dispensary shall be submitted to the City Clerk on a form provided by the City **FOR PRELIMINARY REVIEW BY CITY STAFF TO CONFIRM THAT THE APPLICANT HAS SUBMITTED A COMPLETE APPLICATION**, which shall fulfill all of the requirements indicated on the form, including but not limited to:

(a) If the medical marijuana dispensary commenced operation prior to passage of the moratorium by City Council on August 5, 2010, then proof of the date on which the medical marijuana dispensary commenced operation shall be provided.

(b) The **NAME AND** address of the medical marijuana dispensary and any other contact information requested on the application form. ...

AN APPLICATION TO AMEND AN EXISTING LICENSE TO CHANGE ANY OTHER INFORMATION ON THE MOST RECENT APPLICATION ON FILE WITH THE CITY MAY BE SUBMITTED AT ANY TIME.

(E) APPLICATIONS FOR RENEWAL OR AMENDMENT OF EXISTING LICENSES SHALL BE REVIEWED AND GRANTED OR DENIED BEFORE APPLICATIONS FOR NEW LICENSES ARE CONSIDERED.

([3]4) License Requirements. FOLLOWING OFFICIAL CONFIRMATION BY STAFF THAT THE APPLICANT HAS SUBMITTED A COMPLETE APPLICATION, [A] a new license shall not be issued to a medical marijuana dispensary until the applicant for the license complies with all of the following requirements:

[(a) The applicant has submitted a complete application and the application fee.

(b) The proposed dispensary or cultivation facility is located in a zoning district permits its operation.]

([c]A) The applicant has a valid and current certificate of occupancy.

([d]B) The applicant has installed a sign in a location visible to all persons who enter the premise, which contains the following statement in letters that shall be no less than one inch high: ...

**([d]E) the date of delivery, weight, type of marijuana and dollar amount or other consideration being exchanged in the transaction;**

**([e]F) a certification that all marijuana in any form contained in the package was cultivated, manufactured, and packaged in the state of Michigan;**

**([f]G) the warning that:**

**THIS PRODUCT IS MANUFACTURED WITHOUT ANY REGULATORY OVERSIGHT FOR HEALTH, SAFETY OR EFFICACY. THERE MAY BE HEALTH RISKS ASSOCIATED WITH THE INGESTION OR USE OF THIS PRODUCT. USING THIS PRODUCT MAY CAUSE DROWSINESS. DO NOT DRIVE OR OPERATE HEAVY MACHINERY WHILE USING THIS PRODUCT. KEEP THIS PRODUCT OUT OF REACH OF CHILDREN. THIS PRODUCT MAY NOT BE USED IN ANY WAY THAT DOES NOT COMPLY WITH THE MICHIGAN MEDICAL [MARIJUANA] MARIHUANA ACT OR BY ANY PERSON WHO DOES NOT POSSESS A VALID[ MEDICAL MARIJUANA PATIENT REGISTRATION CARD] REGISTRY IDENTIFICATION CARD.**

**([f]H) The name, address, e-mail address, and telephone number of an authorized representative of the medical marijuana dispensary whom a registered qualifying patient can contact with any questions regarding the product.**

**([g]I) The name, address, e-mail address, and telephone number of at least one governmental or non-profit organization that may be contacted by a registered qualifying patient who has concerns about substance abuse of drugs, including marijuana.**

**(5) All of the required labeling information, including coded registered qualifying patient and registered primary caregiver information shall be maintained[ and available for inspection at] BY a medical marijuana dispensary for no less than one year after dispensing AND AVAILABLE FOR INSPECTION BY THE CITY.**
