## Proposed Greenbelt Boundary Change - Dan Ezekiel, Greenbelt Advisory Commission Chair

*Dan Ezekiel, Chair of the Greenbelt Advisory Commission, presented the proposed Greenbelt boundary changes. He said that the Greenbelt is a resource providing views, water quality, food security and in some cases, recreation access in nearby townships to the City. The Commission recommended to City Council to expand the boundary of the Ann Arbor Greenbelt by pushing the current boundaries out one mile in Salem and Lodi Townships. The result would be to add seven sections in Lodi and three sections in Salem. The recommendation also includes a technical fix to the Greenbelt Ordinance dealing with parcels under the same ownership, but on different sides of the Greenbelt boundary.*

**1. Brenda Oelbaum - Public Art (C-1)**

*Brenda Oelbaum, 3060 Newcastle Rd., addressed Council regarding Public Art. She said that one percent (1%) for art is needed, not one-half percent (1/2%), as presented in the proposed change in the Public Art Ordinance. She urged Council to consider the public value that is achieved through public art projects.*

**2. Thomas Partridge - Give real reason for Thanksgiving. End illegal discrimination and corruption. Provide access to affordable transportation and housing (I-5, I-9)**

*Thomas Partridge, Ann Arbor resident, addressed Council regarding a real reason for Thanksgiving, ending illegal discrimination and corruption in government and to provide real access to affordable transportation and housing.*

**3. Margaret Erickson - Public Art (C-1)**

*Margaret Erickson, 1910 Old Orchard Ct., spoke in opposition to the proposed changes to the Public Art Ordinance. She said that one of her reasons for moving to Ann Arbor is because it has a rich and accessible cultural life. Like festivals and markets, works of public art around the community provide a vital social fabric that connects a community.*

**4. Margaret Parker Percent for Art (C-1)**

*Margaret Parker, 2972 Parkridge Dr., AAPAC member, spoke in opposition to the proposed changes to the Public Art Ordinance. She thanked Council for the support of public art in the past. She added that one penny from each dollar spent on large city capital projects goes to public art. This funding does not raise the cost of any project; it is budget neutral and is a well proven way to fund public art, she stated.*

**5. Wilfred Simbuerger - Public Art (C-1)**

*Wilfred Simbuerger, 1109 Woodlawn Ave., AAPAC member, addressed Council regarding the proposed Public Art Ordinance and urged Council to take a more comprehensive approach that balances cuts to the program. She said that changes to the program may be necessary, but the approach should not be merely focused on cutting the budget, but on structural improvements as well.*

**6. Connie Brown - Percent for Public Art (C-1)**

*Connie Brown, 208 Pine Ridge, AAPAC member, spoke in opposition to the proposed decrease in the funding of the Public Art Ordinance. She said that providing public art allows art to be accessible to the entire community and to visitors as well. She also highlighted some of AAPAC's recent projects.*

**7. Jan Newman - Public Art (C-1)**

*Jan Newman, 1071 Young Place, said that the City has been able to establish a 1% for art and has been able to commission an appropriate sculpture for City Hall, as a result of the program. She added that it is exciting to citizens to be a part of these new projects and it makes the community proud.*

**8. Mark Tucker - Percent for Public Art (C-1)**

*Mark Tucker, 1716 Shadford Rd., said that he was speaking before Council to represent art itself, not people who are in support of public art. He said 1% is not enough and suggested that the community should be talking about 2% for public art.*

**9. Elaine Sims - Public Art**

*Elaine Sims, 2107 Devonshire Rd., AAPAC member, asked that Council maintain the 1% for art level of funding. She urged Council to not change the existing ordinance.*

**10. Keri Hardy - Cherry Republic Donation Check (INT-2)**

*Keri Hardy, 223 S. Main St., on behalf of the owner of Cherry Republic, presented a check in the amount of \$2500.00 to the Ann Arbor Greenbelt program. Cherry Republic is a Michigan retail company that exclusively sells cherries and cherry products from Michigan.*

**COMMUNICATIONS FROM COUNCIL**

**COUNCILMEMBER DEREZINSKI**

*Councilmember Derezinski announced that Washtenaw County received a \$3 million award for the Washtenaw County Sustainable Community Project. The U.S. Department of Transportation, MDOT and the EPA wanted to see collaboration among communities, which was the key to receiving the grant, primarily for planning along the Washtenaw corridor and surrounding communities.*

*Councilmember Teall said that she attended the Ann Arbor Bridges Project meeting. The Stadium bridge construction will officially start on November 28, 2011. Detours will be set up and can be found on the [www.annarborbridges.org](http://www.annarborbridges.org) webpage.*

**COUNCILMEMBER HIGGINS**

*Councilmember Higgins reported that a Resolution to appoint Stephen Rapundalo to the LDFA was being proposed tonight and to be considered for approval at the December 5, 2011 meeting.*

**COUNCILMEMBER ANGLIN**

*Councilmember Anglin said that the Fox Tent and Awning site at 618 S. Main is being considered for development. The developer is hosting a meeting at the site on November 22, 2011 from 5-7 p.m. to discuss proposed plans. Councilmember Anglin noted that this will be the first development under the new D-2 zoning. He encouraged residents in the neighborhood to come out and meet the developer and obtain more information regarding the proposal.*

**COUNCILMEMBER BRIERE**

*Councilmember Briere said that she attended a presentation by the Michigan Attorney General regarding enforcement of the Medical Marijuana Act. She said that she kept a copy of the information that was handed out and could provide the information to councilmembers electronically if they would like to have it.*

- a.) **Lodi Township - that portion of land located within Sections 1—[34] and [10]9—[15]16, AND 21-24, R5E, and lying East of Zeeb Road and North of Pleasant Lake Road.**
- b.) **Pittsfield Township - that portion of land located within Section 1, 12—24, and to the extent not incorporated within the City, Sections 6-8, R63, and lying North of Textile Road.**
- c.) **Scio Township - that portion of land located within Sections 1—4, 9-16, 21—28 and 33—36, R5E, and lying west of Zeeb Road.**
- d.) **Ann Arbor Township all that portion of land within Sections 1—8, 12-13, and to the extent not incorporated within the City, Sections 9—11, 14, 23—25, and 36, R6E, being all the land within the known and designated boundaries of the Township.**
- e.) **Superior Township— that portion of land located within Section 3—10, 15—22, and 27—34, R7E, and lying east of Prospect Road.**
- f.) **Webster Township - that portion of land located within Sections 21—28 and 33—36, R5E, and lying South of 5 Mile Road and west of Zeeb Road.**
- g.) **Northfield Township -that portion of land located within Sections 19—36, R6E, and lying South of 5 Mile Road.**
- h.) **Salem Township - that portion of land located within Sections 19—[36]22,AND 27-34, R7E, and lying South of 5 Mile Road and west of Curtis Road.**
