1. [15-0929](#) Resolution to Approve a Request from Lucky's Market of Ann Arbor, LLC for a New Resort Class C Liquor License and a New SDD/SDM Liquor License to be Located at 1919 S. Industrial Highway, d/b/a Lucky's Market

The Committee discussed with staff the eligibility of the applicant for a Resort License designation, noting that the applicant, Lucky's Market of Ann Arbor, LLC did not meet any of the listed criteria as defined by the Michigan Liquor Control Commission, including:

Full service restaurant with seating for at least 100 persons

Lodging with a minimum of 25 bedrooms or conference rooms for 200 persons

Sports/entertainment venue

Located on a golf course

City Clerk Beaudry noted that the application was provided to Fire and Building and there were no objections.

The Committee stated that they had no objections to the approval of the new SDD/SDM License. (Beaudry noted that Council approval was not required for the sale of packaged beer and spirits.)

A motion was made by Councilmember Kailasapathy, seconded by Councilmember Lumm, that the resolution be approved by the Commission. On a roll call, the vote was as follows with the Chair declaring the motion defeated, noting that the applicant did not meet the criteria outlined by the MLCC for a Resort designation:

Update on Pedal Pubs Legislation

Assistant City Attorney Mary Fales reported to the committee on the "pedal pub" legislation that was signed by Governor Snyder on July 15. The two Acts are PA 126 and 127. Ms. Fales noted that PA 126 gives cities the authority to regulate or prohibit, but noted that otherwise the law allows the operation.

The committee discussed the issue with staff and decided that the DDA, Parks, Police and the UM should be consulted for a recommendation and/or analysis of the issue.
