*Julie Quiroz, 900 W. Huron, spoke in support of DC-1, the Resolution Directing the City Administrator and City Attorney to Report to City Council on Issues Raised by Presidential Executive Order Dated January 25, 2017. She urged Council to approve sanctuary city status for Ann Arbor.*

- 2. Roger Kuhlman - City of Ann Arbor Rule of Law and U. S. Immigration Policy (DC-1)**

*Roger Kuhlman, 2421 Placid Way, spoke in opposition to DC-1, stating illegal aliens, especially those committing crimes, do not deserve protection. He urged Council not to spend Ann Arbor tax dollars on this issue.*

- 3. Allison Hight - Resolution Directing the City Administrator and City Attorney to Report to City Council on Issues Raised by Presidential Executive Order Dated January 25, 2017 (DC-1)**

*Allison Hight, from the University of Michigan Labor Law Association, spoke in support of DC-1, and the call for Ann Arbor to become a sanctuary city. She urged Ann Arbor to act quickly and suggested a sanctuary ordinance would be stronger and have more impact than a resolution. Ms. Hight submitted petitions from the community in support of an ordinance.*

**4. Paula Uche - Resolution Directing the City Administrator and City Attorney to Report to City Council on Issues Raised by Presidential Executive Order Dated January 25, 2017 (DC-1)**

*Paula Uche, 482 Village Oaks, spoke in support of DC-1, and urged Council to be leaders.*

**5. Ellen Fisher - Petition WCWRC for Design & Construction of Stormwater Management Measures for Churchill Park Pond (CA-8)**

*Ellen Fisher, 2100 Churchill Drive, spoke about flooding issues on the City's southwest side. She urged Council to support CA-8 to petition the County Water Resources Commissioner to implement stormwater management solutions in her neighborhood.*

**6. Stephanie Preston - School Safety Report (AC-2)**

*Stephanie Preston of A2 Safe Transport addressed the City Administrator's School Safety Report. She urged Council to continue to take further action, stating improved crosswalks are still needed.*

**7. Sarah Cohen of Ann Arbor Safe Transport - School Safety Report (AC-2)**

*Sarah Cohen of Ann Arbor Safe Transport spoke about the School Safety Report and urged Council to do more.*

**8. Judith Hoffman - School Safety Report (AC-2)**

*Judith Hoffman spoke about the Administrator's School Safety Report, stating improvements are still needed at Community High School. She asked staff to consider a speed limit sign on Division and Fifth near Community High. She also asked that a school zone be posted on Division Street.*

**9. Peter Houk - School Safety Report (AC-2)**

*Peter Houk, Washtenaw Walking and Biking Coalition, spoke about the School Safety Report and urged Council to make more improvements.*

**10. Claire Duvernoy - School Safety Report (AC-2)**

*Claire Duvernoy, 641 Geddes Ridge, on behalf of A2Safe Transport, spoke about the School Safety Report and stated there are still problems at Huron High School, noting that the street lights are currently not lighted.*

**CC COMMUNICATIONS FROM COUNCIL**

**COUNCILMEMBER LUMM**

*Councilmember Lumm responded to public comments regarding the School Safety Report. She thanked the City Administrator and staff for the report, but stated more information on plans and commitments is needed. Councilmember Lumm stated a priorities list and cost estimates are needed.*

**COUNCILMEMBER EATON**

*Councilmember Eaton thanked Councilmember Lumm for her comments on the School Safety Report and stated he agrees. Councilmember Eaton also spoke about the CTN budget, including a proposed budget for closed captioning for City Council and the Planning Commission. Councilmember Eaton addressed the recent emails regarding the airport expansion, stating a meeting recently took place regarding the environmental assessment of the site. He urged new Councilmembers to discuss the issue with airport neighbors and learn about the history of this project.*

*Councilmember Eaton also reported that the School Safety Committee is meeting at 1pm tomorrow at Balas.*

**COUNCILMEMBER KAILASAPATHY**

*Councilmember Kailasapathy thanked the public for their advocacy and support regarding Ann Arbor's sanctuary city status. She noted that the resolution in front of Council today is a first step. She urged the Ann Arbor community to be on the right side of history.*

**COUNCILMEMBER GRAND**

*Councilmember Grand also thanked the public for emailing Council and for attending tonight's meeting in support of sanctuary city status. She also addressed the Tobacco 21 ordinance and stated the recent Attorney General opinion does not invalidate Ann Arbor's ordinance. She spoke about the long-term health benefits of preventing tobacco use in young people.*

*Jim Deng, 2130 Steeplechase Drive, expressed concern about the approved stormwater project in his neighborhood. He urged Council to consider the impacts to the entire area, not just a few neighbors' concerns when making decisions about stormwater.*

*Terry Abrams, Ward 3, spoke about the deer cull and the lack of transparency. He urged Council to consider the welfare of wildlife, expressing his displeasure at the treatment of a sterilized doe who suffered for days before being put down.*

*Angela Johnson, representing the Ann Arbor Center for Independent Living, spoke about the work of the CIL and encouraged Council to attend their upcoming Gala event.*

*Ed Vielmetti, Ward 4, stated he attended a Brownfield Review Board meeting. He stated it was very difficult to get copies of the board packet materials. He urged staff to make this information more transparent and accessible for the public.*

*Kathy Griswold, A2 Safe Transport, thanked City Administrator Howard Lazarus for the report issued on School Safety. She urged Council to continue their efforts, stating children should not be walking to school in the dark.*

*Lindsay Krantz, Ypsilanti Township resident, addressed Council's sanctuary city resolution and spoke about other impacts of President Trump's administration, including cuts to community radio.*

*Greg Pratt, Ann Arbor, spoke about the Washtenaw County Sheriff's Crisis Response Team. He expressed concern about the SWAT response to a recent situation in Ypsilanti. He said he was very upset about Police-involved shootings and noted that Ann Arbor was part of this recent response team in Ypsilanti.*

*An unknown First Ward resident thanked Councilmember Kailasapathy for her kind words regarding sanctuary city status. He also thanked Council for their advocacy for people with disabilities and the approval of the Closed Captioning ordinance.*

*Kendall Stagg, representing Trinity Health, spoke about the Tobacco 21 Ordinance. He stated Trinity Health is still standing with Ann Arbor as a partner. He expressed disappointment with the media reporting that Ann Arbor's Tobacco 21 law is illegal. He urged Council to state publicly that it is still enforcing its ordinance.*

*Dave Hodgkins of the American Heart Association spoke in support of Ann Arbor's*

*Tobacco 21 ordinance and stated the American Heart Association is still a partner with the City on this issue.*

*Steve Carter, Ward 5, spoke in support of sanctuary cities and urged Council not to worry about the loss of federal dollars. He asked Council not to make partisan statements.*
