Residential Parking Permits will only be issued TO APPLICANTS LIVING IN THE AFFECTED AREA. You must show proof that residency has been established by providing a copy of:

- 1. Motor vehicle registration showing the vehicle is registered in your name...
2. One of the Following:
a. Current utility bill...
b. Rent or lease agreement...
c. Notarized declaration...
d. Driver's license...

Applications may be made either through the mail or taken in person to the 1st floor counter at the City Center Building located at 220 E. Huron... Replacement permits are \$30 when returning previous permit or pieces including the permit number...

The residential parking permit shall be permanently affixed to the lower, left front windshield (driver's side). It shall be unlawful and a violation of this application agreement for the person to falsely represent him or herself as eligible for a parking permit...

- (a) For a person holding a valid residential parking permit to use or display the permit on a vehicle other than for which the permit was issued.
(b) To use, or allow to be used, a residential parking permit for commuter parking.
(c) For a person to copy, produce or otherwise create a facsimile or counterfeit residential parking permit in order to evade parking regulations...

VIOLATION FOR ANY OF THE REASONS OUTLINED ABOVE WILL RESULT IN LOSS OF PERMIT

REVOCAION OF PERMIT: Representatives of the City Administrator are authorized to revoke the residential parking permit of any person found to be in violation of the agreement and upon written notification thereof, the person shall surrender such permit to the representative.
