Hi Lori,

Has the developer responded with a "a plan to either avoid harm to the species or evidence that the species is no longer present at the site" as you requested in the attached letter? There will be a city meeting this Friday and if they have not yet responded I wanted to call them on it. They have submitted a site plan which involves discharging the effluent from their chemically treated lawns about 300 feet from where the dukes was sighted. IMO this will negatively affect the Dukes' habitat.
