1. Tom Partridge - Expand Affordable Public Transportation and Housing

Tom Partridge, Ann Arbor resident, addressed Council regarding expanding affordable public transportation and housing.

2. Weston Vivian - Citizens United

Weston Vivian, 1200 Earhart Rd., asked that Council pass a Citizens United Resolution indicating the City's desire to reverse the decision made by a Supreme Court Judge, similar to what other communities have done on this issue.

3. Kermit Schlansker - Solar Energy

Kermit Schlansker, 2960 Marshall, spoke in favor of building new nuclear power plants and explained how solar, wind, bio-mass and earth heat together can benefit the community as a whole.

4. Eleanor Linn - Update S. University Apartment Construction

Eleanor Linn, 1321 Forrest Ct., expressed concern with the construction of the S. University student high-rise apartment building construction. She said that it has been four years since construction began on the high-rise apartment building. She provided Council with a list of issues in the neighborhood since the construction began and the building opened, including more cars and parking problems than anticipated, garbage and poor landscaping.

5. Wayne Appleyard - 25% by 2025 Resolution from Energy Commission

Wayne Appleyard, 5750 Prospect Hill, Grass Lake, MI, chair of the Ann Arbor Energy Commission, spoke in support of the proposed 25% by 2025 Resolution from the Energy Commission. He urged Council to support the Commission's resolution and to support State ballot proposal 3.
