**1. Gersh Avery - Medical Marijuana (C-1)**

*Gersh Avery addressed Council regarding the Medical Marijuana Ordinance. He asked that Council make the City of Ann Arbor a city for medical advancement and protect the testing facilities that are necessary to ensure the health and the life of cancer patients.*

**2. Rhory Gould - Medical Marijuana (C-1)**

*Rhory Gould, 5537 Overbrook, thanked Council for drafting the Medical Marijuana Ordinance and expressed concerns with the portion of the ordinance that required keeping permanent records of people who are legally growing cannabis under state law. Mr. Gould stated there are concerns amongst caregivers regarding privacy and the ordinance as proposed may limit the number of people willing to supply dispensaries.*

**3. Dennis Hayes - Medical Marijuana (C-1)**

*Dennis Hayes thanked Council for the work that has been done on the Medical Marijuana Ordinance. The current version of the ordinance contains a substantial number of restrictions that are still of concern to the medical marijuana community.*

**4. Chuck Ream - Medical Marijuana (C-1)**

*Chuck Ream expressed concerns with portions of the proposed Medical Marijuana Ordinance. He said that the cultivation license is an attempt to restrict rights that are already provided by the Michigan Medical Marijuana Act. He reminded Council that City voters overwhelmingly supported the constitutional amendment.*

**5. Henry Herskovitz - Palestine**

*Henry Herskovitz, 404 Mark Hannah, asked that Council consider two items to promote peace in Palestine. He asked that Council pass the Human Rights Resolution calling for cessation of military aid to Israel and invited Council to attend their group's forum which will be held on March 29, 2011 at the Malletts Creek Branch of the Ann Arbor District Library.*

**COMMUNICATIONS FROM COUNCIL****COUNCILMEMBER TAYLOR**

*Councilmember Taylor reported on the City's and the DDA's Mutually Beneficial Committees. The two have been meeting to discuss contractual language for a parking agreement. Councilmember Taylor stated there are still some outstanding issues to resolve, but progress is being made.*

**COUNCILMEMBER RAPUNDALO**

*Councilmember Rapundalo responded to an article in AnnArbor.com. He clarified some comments made regarding Act 312 and binding arbitration. Councilmember Rapundalo also clarified comments in the article that made reference to past negotiated agreements and he stated the City recognizes that both sides negotiated in good faith for those agreements based on the needs at that time. The economic circumstances today are different than they were even two or three years ago and what the City is asking for in terms of concessions in future contracts now is a reflection of today's economic reality.*

*Councilmember Rapundalo also clarified that the City was not proposing to reduce the health care benefits for the Ann Arbor Police Officers Association, as was reported. He stated that the groups who have already agreed to the new health care plan have similar or in some cases, such as preventive care, improved benefits. The City has never sought a reduction in benefits, but is requesting that employees share in the increasing costs of health care both now and in retirement.*

**COUNCILMEMBER ANGLIN**

*Councilmember Anglin reported on the Police Department handing a case in the 5th Ward. He commended the police for their efforts.*

**COUNCILMEMBER BRIERE**

*Councilmember Briere thanked everyone who reviewed the Street Outreach Committee's Report. One of the tasks of the committee was to think about new ways to confront panhandling and by extension, both homelessness and the needs for additional human services without increasing the budget. She added that an ordinance to amend the panhandling chapter of the City Code would be coming soon.*

**COMMUNICATIONS FROM THE CITY ADMINISTRATOR***INTERNATIONAL EARTH HOUR*

*City Administrator Roger Fraser said that the City would be participating in International Earth Hour on Saturday, March 26, 2011, from 8:30 p.m. to 9:30 p.m. The street lights will be turned off on Main Street between William and Huron Streets during this time period. - C-1 10-1249** An Ordinance to Add a New Chapter 95 to Title VII (Medical Marijuana Licenses for Cultivation Facilities and Dispensaries) of the Code of the City of Ann Arbor

A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:

**Amendment #1**

**AN ORDINANCE TO ADD A NEW CHAPTER [71]95 TO TITLE [VI]VII [FOOD AND HEALTH](BUSINESSES AND TRADES) OF THE CODE OF THE CITY OF ANN ARBOR.**

The City of Ann Arbor Ordains:

Section 1. That a new Chapter [71]95 be added to Title [VI]VII of the Code of the City of Ann Arbor to read as follows:

**CHAPTER [71]95. MEDICAL MARIJUANA [BUSINESS] LICENSES FOR CULTIVATION FACILITIES AND DISPENSARIES ...**

Note: [ ] Brackets indicate deleted language. All CAPS indicate new language.

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:

**Amendment #2**

**Section 6:415. License Required, Number of Licenses Available, Eligibility.**

...(2) [A cultivation facility or dispensary shall not be eligible for a license if any person required under this chapter to be named on the application has been convicted of any felony under Michigan law, or the law of any other state or the United States.] **A CULTIVATION FACILITY OR DISPENSARY SHALL NOT BE ELIGIBLE FOR A LICENSE IF ANY PERSON REQUIRED UNDER THIS CHAPTER TO BE NAMED ON THE APPLICATION HAS EVER BEEN CONVICTED OF A FELONY INVOLVING CONTROLLED SUBSTANCES AS DEFINED UNDER THE MICHIGAN PUBLIC HEALTH CODE, MCL 333.1101, ET SEQ, THE FEDERAL LAW, OR THE LAW OF ANY OTHER STATE. ...**

On a voice vote, the Mayor declared the motion carried, with one no-vote made by Councilmember Rapundalo.



A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:

**Amendment #3**

**Section 6:415. License Required, Number of Licenses Available, Eligibility.**

...(7) The City Council will establish a licensing board to consist of one member of Council, one physician, and three other Ann Arbor residents, these are Mayoral appointments. The Board will annually review and recommend the licensing criteria, the number of licenses authorized, the license fee structure **TAKING INTO CONSIDERATION RECOMMENDATIONS FROM STAFF**, and recommend approval of license applications. While a cultivation facility or dispensary shall not be eligible for a license if any person required under this chapter to be named on the application has been convicted of a felony involving controlled substances, evidence that a person required under this chapter to be named on the application has been convicted of any other type of felony, under the law of Michigan, the United States, or another state, may be used by the Board in its determination of whether or not to recommend the issuance of a license to the applicant. Among other things, the Board shall consider whether the substance of the offense would tend to indicate a likelihood that the person would be unable to serve the public in a fair, honest and open manner or to dispense or cultivate medical marijuana in compliance with the MMMA, whether there is evidence that the person has been rehabilitated, and the age of the conviction. ...

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:

**Amendment #4**

**Section 6:415. License Required, Number of Licenses Available, Eligibility.**

...(9) **MEDICAL MARIJUANA HOME OCCUPATIONS DO NOT REQUIRE LICENSES BUT MAY REGISTER WITH THE CITY BY PROVIDING THE ADDRESS OF THE HOME OCCUPATION AND SHOWING THE REGISTRY NUMBER ON THE CAREGIVER REGISTRY IDENTIFICATION CARD THAT THE MDCH ISSUED TO THE CAREGIVER WHO IS DELIVERING THE MARIJUANA. ...**

On a roll call, the vote was as follows, with the Mayor declaring the motion carried:

**Amendment #5**

**Section 6:417. Application Requirements for New Annual License or Renewal of Existing License; License Requirements for New License and for Renewed License.**

**(1) APPLICATION ACCEPTANCE.** A dispensary or cultivation facility that commenced operation prior to passage of the moratorium by City Council on August 5, 2010, shall have until sixty (60) days after the effective date of this chapter to submit an application for a new annual license. No other applications will be accepted by the City until seventy-five (75) days after the effective date of this chapter. The cultivation facility or dispensary may continue to operate pending final action on the application unless the Building Official determines that it must be closed for safety reasons. Within 60 days after an application is denied, the cultivation facility or dispensary shall discontinue all operation unless the Building Official determines it must be closed sooner for safety reasons.

**(2) APPLICATION REQUIREMENTS.** An application for a new annual license or the renewal of an existing license for a cultivation facility or dispensary, shall be submitted to the City Clerk on a form provided by the City, which shall fulfill all of the requirements indicated on the form, including but not limited to: ...

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:

**Amendment #6**

**Section 6:417. Application Requirements for New Annual License or Renewal of Existing License; License Requirements for New License and for Renewed License.**

**...(3)(d) The applicant has installed a sign [containing] IN A LOCATION VISIBLE TO ALL PERSONS WHO ENTER THE PREMISES, WHICH CONTAINS the following statement IN LETTERS THAT SHALL BE NO LESS THAN ONE INCH HIGH: ...**

On a voice vote, the Mayor declared the motion carried.

*Councilmember Derezinski was absent during the time of this vote.*

**A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:**

**Amendment #7**

**Section 6:419. Conduct of Business at Cultivation Facility or Dispensary.**

**...(4) All marijuana delivered to a patient shall be packaged and labeled as provided in this chapter. The label shall include:**

**Delete:**

- [(a) the name of the person to whom it is being delivered;**
- (b) the name of the business delivering the marijuana;**
- (c) that the package contains marijuana;**
- (d) the date of delivery, weight, type of marijuana and dollar amount or other consideration of being exchanged in the transaction; and,**
- (e) the warning that:**

**THIS PRODUCT IS MANUFACTURED WITHOUT ANY REGULATORY OVERSIGHT FOR HEALTH, SAFETY OR EFFICACY. THERE MAY BE HEALTH RISKS ASSOCIATED WITH THE INGESTION OR USE OF THIS PRODUCT. USING THIS PRODUCT MAY CAUSE DROWSINESS. DO NOT DRIVE OR OPERATE HEAVY MACHINERY WHILE USING THIS PRODUCT. KEEP THIS PRODUCT OUT OF REACH OF CHILDREN. THIS PRODUCT MAY NOT BE USED IN ANY WAY THAT DOES NOT COMPLY WITH THE MICHIGAN MEDICAL MARIJUANA ACT OR BY ANY PERSON WHO DOES NOT POSSESS A VALID MEDICAL MARIJUANA PATIENT REGISTRATION CARD.**

**(f) The name, address, e-mail address, and telephone number of an authorized person who a patient can contact with any questions regarding the product.**

**(g) The name, address, e-mail address, and telephone number of at least one organization who may be contacted by a patient who has concerns about substance abuse of drugs, including marijuana.]**

**Add new:**

- ...(A) A UNIQUE ALPHANUMERIC IDENTIFIER FOR THE PERSON TO WHOM IT IS BEING DELIVERED;**
- (B) A UNIQUE ALPHANUMERIC IDENTIFIER FOR THE CULTIVATION SOURCE OF THE MARIJUANA;**
- (C) THAT THE PACKAGE CONTAINS MARIJUANA;**
- (D) THE DATE OF DELIVERY, WEIGHT, TYPE OF MARIJUANA AND DOLLAR AMOUNT OR OTHER CONSIDERATION BEING EXCHANGED IN THE TRANSACTION; AND,**
- (E) A CERTIFICATION THAT ALL MARIJUANA IN ANY FORM CONTAINED IN THE PACKAGE WAS CULTIVATED, MANUFACTURED, AND PACKAGED IN THE STATE OF MICHIGAN.**
- (F) THE WARNING THAT:**

**THIS PRODUCT IS MANUFACTURED WITHOUT ANY REGULATORY OVERSIGHT FOR HEALTH, SAFETY OR EFFICACY. THERE MAY BE HEALTH RISKS ASSOCIATED WITH THE INGESTION OR USE OF THIS PRODUCT. USING THIS PRODUCT MAY CAUSE DROWSINESS. DO NOT DRIVE OR**

OPERATE HEAVY MACHINERY WHILE USING THIS PRODUCT. KEEP THIS PRODUCT OUT OF REACH OF CHILDREN. THIS PRODUCT MAY NOT BE USED IN ANY WAY THAT DOES NOT COMPLY WITH THE MICHIGAN MEDICAL MARIJUANA ACT OR BY ANY PERSON WHO DOES NOT POSSESS A VALID MEDICAL MARIJUANA PATIENT REGISTRATION CARD.

(G) THE NAME, ADDRESS, E-MAIL ADDRESS, AND TELEPHONE NUMBER OF AN AUTHORIZED REPRESENTATIVE OF THE DISPENSARY WHOM A PATIENT CAN CONTACT WITH ANY QUESTIONS REGARDING THE PRODUCT.

(H) THE NAME, ADDRESS, E-MAIL ADDRESS, AND TELEPHONE NUMBER OF AT LEAST ONE GOVERNMENTAL OR NON-PROFIT ORGANIZATION THAT MAY BE CONTACTED BY A PATIENT WHO HAS CONCERNS ABOUT SUBSTANCE ABUSE OF DRUGS, INCLUDING MARIJUANA.

(5) ALL OF THE REQUIRED LABELING INFORMATION, INCLUDING CODED PATIENT AND CAREGIVER INFORMATION SHALL BE MAINTAINED AND AVAILABLE FOR INSPECTION AT A CULTIVATION FACILITY OR DISPENSARY FOR NO LESS THAN ONE YEAR AFTER DISPENSING.

[(5)](6) A cultivation facility or dispensary shall report all criminal activities to the Ann Arbor Police Department immediately upon discovery.

[(6)](7) An authorized person shall consent to the entry into a cultivation facility or dispensary by the Building Official and zoning inspectors for the purpose of inspection to determine compliance with this chapter pursuant to a notice posted in a conspicuous place on the premises two (2) or more days before the date of the inspection or sent by first class mail to the address of the premises four (4) or more calendar days before the date of the inspection.

[(7)](8) All security measures required in this chapter shall be maintained in good working order. The premises shall be monitored and secured twenty-four hours per day.

[(8)](9) All marijuana in any form provided to patients at or by a dispensary or cultivation facility shall have been cultivated, manufactured, and packaged in the state of Michigan.

[(9) A cultivation facility or dispensary shall keep records of the persons from whom they received marijuana in any form, and shall make the records available to the City for review upon request.]

(10) A CULTIVATION FACILITY OR DISPENSARY SHALL KEEP RECORDS OF THE CAREGIVERS FROM WHOM THEY RECEIVE MARIJUANA IN ANY FORM, AND SHALL MAKE THE RECORDS AVAILABLE TO THE CITY, UPON REQUEST TO PROMOTE HEALTH, SAFETY AND WELFARE OR TO OTHERWISE VERIFY COMPLIANCE TO THIS CHAPTER. ...

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:

**Amendment #8**

**Section 6:415. License Required, Number of Licenses Available, Eligibility.**

**(8 ) A LICENSE ISSUED UNDER THIS CHAPTER SHALL EXPIRE ONE YEAR AFTER THE DATE OF ISSUANCE.
