- 1. Tom Partridge The Freedom Initiative: Enact affordable county-wide transportation through the 4-Party Agreement. End homelessness and expand affordable housing through city-county planning. (DC-1, I-2)

Tom Partridge, Ann Arbor resident, addressed Council regarding enacting affordable county-wide transportation through the 4-Party Agreement. He also spoke about ending homelessness and the expansion of affordable housing.

2. Jim Mogensen - 4-Party Public Transportation Agreement (DC-1)

Jim Mogensen, 3780 Green Brier, expressed concern with the proposed 4-Party Public Transportation Agreement.

Alexandra Hoffman - City Planning Commission Meeting Minutes of October 18, 2011 (I-2)

Alexandra Hoffman, 1213 McIntyre, addressed Council regarding the homelessness issue in the City. She said that it is not right that Council, who represents all of the town's population, shy away from this important issue and the challenges it brings.

Mary Conway - City Planning Commission Meeting Minutes of October 18, 2011 (I-2)

Mary Conway, 312 W. Huron Street, member of the Delonis Center, thanked Council for their service to the community. She urged Council to engage the homeless population, as they would really like to contribute. She noted that the homeless community feels that they could have a strong voice and could become a volunteer group in Ann Arbor.

Orian Zakai - City Planning Commission Meeting Minutes of October 18, 2011 (I-2)

Orian Zakai, 111 N. First St., said that there is a necessity for establishing an additional warming center in Ann Arbor. A warming center should be available around the clock for those residents in the community who do not have their own homes. She questioned Council regarding the possible renovation of the City-owned facility at 721 N. Main.

6. Kermit Schlansker - Sewage - Better methods of disposal and use in agriculture.

Kermit Schlansker, 2960 Marshall St., addressed Council regarding better methods of sewage disposal and its use in agriculture.

7. Lily Au - City Planning for accommodation

Lily Au, 682 Peninsula Ct., addressed Council regarding the homeless population in Ann Arbor. She expressed concern with the City's handling of block grant monies and spoke in opposition to the coordinated funding plan.

8. Herb David - Retail Businesses on Liberty

Herb David, 302 E. Liberty, addressed Council regarding his business, Herb David Guitar, on Liberty Street and the impact of the DDA construction project to his business.

9. Ali Ramlawi - Role of DDA

Ali Ramlawi, 428 S. Seventh Street., welcomed Councilmember Lumm to the Council. Mr. Ramlawi asked when Fifth Ave. would reopen, stating the closure has had a very negative impact on the surrounding businesses. He stated the DDA has promised several times that the street would reopen, including August 2011 and January 2012. He reiterated previous comments that the street closure and construction is hurting local businesses.

10. Glenn Granger - Tentative Award of WWTP Construction Contract (DS-5)

Glenn Granger, 11751 Ramson Highway, Diamondale, Michigan, Chief Executive Officer of Granger Construction Company, addressed Council regarding the RFP process for the Wastewater Treatment Plant construction project. He stated that the City is wasting \$3,000,000 by not choosing the lowest responsible bidder. He urged Council to relook at the award of this contract.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman inquired about the TIF report that was due to Council from the DDA for 2011.

COUNCILMEMBER HIGGINS

Councilmember Higgins announced that the Council Budget Committee met in January and they asked to have a work plan put together for the upcoming budget. Staff has put an agenda together for this budget year and it will be shared with Council. The first budget work session is scheduled for February 13, 2012, covering budget overview, strategy and Police impacts, as well as VEBA and Pension. Another work session could be scheduled for February 27, 2012 if needed. The next scheduled budget work session will take place on March 12, 2012 to discuss the Fire Department and other organizational impacts. March 26, 2012 is another date that will be held as a possible follow-up work session if needed.

Councilmember Higgins noted that the City Administrator will present his recommended budget on April 16, 2012; May 7, 2012 is the scheduled public hearing of the budget and proposed fee changes, with May 21st being the consideration of the budget for adoption by Council.

COUNCILMEMBER ANGLIN

Councilmember Anglin spoke about the proposed 4-party agreement with the AATA. He urged members of the community who still have questions and comments to get those to Council now while the item is still being debated.

COUNCILMEMBER DEREZINSKI

Councilmember Derezinski updated Council on the Ann Arbor Public Art Commission. He said that the Commission met 10 days ago and they started to review projects in an effort to compile an annual work plan. Councilmember Derezinski stated that a number of exciting projects are being reviewed, including a new piece of art work for the atrium of City Hall. A citizen survey is also in the works to solicit public input.

COUNCILMEMBER SMITH

Councilmember Smith announced that there are openings on the Human Rights Commission. People who are interested may fill out an application by logging onto the City Clerk's webpage and downloading an application and submitting it to the Mayor's Office.

COUNCILMEMBER LUMM

Councilmember Lumm spoke about the early lease signing ordinance. She stated several councilmembers have been approached by members of the Washtenaw Area

Apartment Owners Association and Michael Benson, President of the U of M Graduate Student Association, about the prospect of reviewing the Early Signing Lease Ordinance. She informed Council that Mr. Benson would be scheduling a forum for graduate and undergraduate students at U of M to discuss this issue.

Mayor Hieftje urged Councilmember Lumm to take into consideration the school calendar if changes are to be proposed to the lease signing ordinance. He stated that the student population was very interested in this ordinance when it was first passed, so they will definitely want any discussions to take place during the school year.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

RESURFACING OF HURON STREET AND JACKSON ROAD

City Administrator Steve Powers informed the public that the Michigan Department of Transportation would be resurfacing Huron St. and Jackson Rd. The project will include the conversion of Jackson Road to three lanes. MDOT will hold a public meeting on February 16, 2012 at 5 p.m. at Slauson Middle School to review the plans to convert the four-lane street into three wider lanes, with bike lanes and marked locations for safe pedestrian street crossings.

After all of the Section 8 contingencies to Closing are satisfied, Ypsilanti agrees to transfer its full respective transportation millages, less a municipal service charge [of one percent (1%)]TO BE NEGOTIATED BY THE CITY ADMINISTRATOR, OF WHICH THE PORTION OF THE SERVICE CHARGE FOR THE COLLECTION OF ANY TAX LEVY SHALL NOT EXCEED THE ALLOWABLE MAXIMUM UNDER STATUTE FOR TAX ADMINISTRATION FEES at the 2012 millage rate or as adjusted by State of Michigan statute to the New TA effective when the New TA succeeds to AATA's public transportation services.

Subsection 5d. In exchange for the mayor's nomination with council confirmation, of seven directors of New TA's board, annual submission to Ann Arbor of the AATA's proposed budget and yearly audit and the New TA's agreement to apprise Ann Arbor City Council and solicit Council's advice prior to making major long-term policy actions concerning mass transportation services and at a minimum, the continued level of services provided by its predecessor-in-interest AATA, Ann Arbor agrees (i) take such necessary actions by its governing body to terminate its operational agreement with AATA effective at closing; (ii) take such necessary actions by its governing body to authorize the execution and delivery of this Agreement and all documents and instruments contemplated by this Agreement, and the performance by Ann Arbor of the obligations to be performed by it hereunder; and (iii) designate the New TA, as successor to AATA, as the contracting agency for use of the 2.5 mills tax levy under Section 8.18 of the Ann Arbor City Charter and allocated the tax levy in its entirely to AATA at the 2012 millage rate or as adjusted by State of Michigan statute less a municipal service charge [of one percent (1%)] TO BE NEGOTIATED BY THE CITY ADMINISTRATOR, OF WHICH THE PORTION OF THE SERVICE CHARGE FOR THE COLLECTION OF ANY TAX LEVY SHALL NOT EXCEED THE ALLOWABLE MAXIMUM UNDER STATUTE FOR TAX ADMINISTRATION FEES of the annual millage at the time of the collection of taxes upon transfer from an Act 55 to an Act 196 authority.

PUBLIC COMMENT - GENERAL (3 MINUTES EACH)

Jim Mogensen, 3780 Green Brier, further expressed concern with the proposed 4-Party transportation agreement. He said that AATA is a public transportation system, not a private business.

Alan Haber, Ann Arbor resident, addressed Council regarding a program that took place at the Michigan Theater called The Penny Stamps Lecture last week. The lecture was about a citizen who took the initiative to help develop a public park in New York City. He urged Council and City residents to consider something like this for the Library lot. He also addressed Council regarding a proposed Warming Center.

Thomas Partridge, Ann Arbor resident, expressed concern with the AATA bus system. He said that the system goes into a complete shutdown between 9:30 p.m. and 10:15 p.m. and that causes problems for people leaving evening meetings.

Mayor Hieftje commented on the 100 units of affordable housing that was mentioned earlier by a public speaker. Mayor Hieftje stated the City is working to replace those units. He explained that they are working diligently and that the units would not be all in one big building downtown, but are being spread out all over the City.

Councilmember Briere asked if the Mayor was meeting with interested residents regarding the Warming Center. Mayor Hieftje said that the North Community Housing Alliance has put together meetings to discuss the Warming Center. He and Councilmember Briere met a couple weeks ago with providers of all of those services, as well as with the county administrator. There is movement and action from some of the non-profit groups on this issue, he stated.
