*Tom Crawford, Chief Financial Officer, introduced the Public Services Area team who presented the proposed Public Services Area budgets, including Streets, Sewer Fund, Solid Waste Fund and Water Fund.*

*Public Services staff Nick Hutchinson, City Engineer; Molly Maciejewski, Public Works Director; Raymond Hess, Transportation Engineer; Marti Praschan, Chief of Staff; Cresson Sloten, Systems Planning Manager; and Earl Kenzie, Wastewater Treatment Plant Manager; were in attendance to answer questions related to their respective areas.*

*Mr. Crawford encouraged Council Members to send any follow-up questions related to the proposed budget to Sara Higgins in the City Administrator's Office, with copies to City Administrator Howard Lazarus, Mr. Crawford and Karen Lancaster, Finance Director.*

*Councilmember Lumm suggested that a Work Session might be needed to thoroughly discuss and review proposed changes in the Solid Waste and Recycling programs and possible regionalization efforts. She stated a lot of background information will be needed by Council before any recommendations or approvals can be made. Councilmember Eaton concurred.*

*Several questions were raised regarding the proposed purchase of snowplow equipment for bike lanes.*

*Council Members asked about plans for addressing sidewalk gaps and how the gaps were prioritized.*

*Councilmember Bannister inquired about sidewalk and snow clearing options for elderly and disabled residents.*
