CALL TO ORDER

Mayor Hieftje called the regular session meeting of the Ann Arbor City Council to order at 7:07 p.m. in the Guy C. Larcom Jr. Municipal Building, 2nd Floor Council Chambers, 100 N. Fifth Avenue.
