Comment: I grew up in Ann Arbor, and my parent's current home (Dr. and Mrs. Jeremiah G. Turcotte, MD (University of Michigan Professor of Surgery Emeritus)) is next door to Inglis House. Our family has enjoyed neighboring Inglis house and has observed many University activities taking place at Inglis House since my parents moved to that home (approximately 1989). The University of Michigan has been the single most important institution in our family history. Both my parents attended the U of M as undergraduates and graduate students, earning an MD and PhD, respectively. My father was on the U of M Medical School faculty for over 50 years. My sister, grandfather, aunt, uncle, cousins, cousin in-law, and currently their daughter all attended U of M. My son, Jeremiah James May, has just this week committed to enter as a freshman in LSA honors next fall.

We are loyal supporters of U of M. However, U of M selling Inglis House without taking the time to consider community input and alternative uses is not the type of action we can be proud of. This is an historic and irreplaceable asset and I urge the University to consider alternative uses. In Cincinnati where I currently live there are examples of former private homes and estates that are currently used as event centers, community centers and even as corporate offices and private

clubs. I urge the University to consider any of these options as well as other uses the community may put forward. Further, if the University cannot support an alternative use, I urge the University to sell the property subject to the restriction suggested by the Inglis family - that the sale be limited to a single family who will occupy the home and not tear the home down or substantially alter it. The University should seek to obtain historic designation for this house to save a treasure!

What kind of message would this action send to past and future donors to the University? Probably, that their wishes will not be remembered or respected. Perhaps the donation was not properly documented as a restricted donation (further research into that should be done, however). But even if it was not, it appears that was likely the intent of the donor. That should be weighed heavily. Respectfully, Claire M. Turcotte
