## Hello,

I am writing to describe a difficult, on-going noise problem that I am having with a neighbor of mine. We are both tenants at the Apartments in Ann Arbor. He lives in the apartment behind me, and we share a common wall that separates our kitchens. He is a year old, quite intelligent man with a mild to moderate case of dementia.

Since last April, he has been making minor to very strong thumping noises on a daily basis. These last up to an hour. I have found that he responds-but only temporarily- if I tap on our common wall 2 or 3 times. In May, there was no noise all for the 2 plus weeks he was away after he suffered a fall on his porch.

I have been able to piece together some information as to the source and nature of the noise from several sources, including from 2 former neighbors who occupied an adjacent apartment together, Ann Arbor police officers who I've had to call in to help me deal with this neighbor's worst episodes of noise making, as well as my own experience of this problem.

Apparently, this neighbor makes certain movements with his hands or feet in his sleep, either while he is in bed or in his large recliner. Supposedly, he is not aware that he is producing these noises when, for example, his feet make contact with the floor.

Also, the 2 former neighbors and me have both been in touch with the Office Mgr. She refused to act on our complaints because in her words, "there is no proof" that the tenant is making the noises.

At this point, apparently, the tenant's daughter and husband are working on moving him to an assisted living situation. However, they are reluctant to do this because of the low quality of places that are available to people like him who lack the financial means to pay for better quality places. Meanwhile, the noise continues.

As a resident of Ann Arbor, I should be protected by the city ordinance against excessive and intrusive noise. I myself am and increasingly vulnerable: However, apparently no one wants to prosecute a year old man who is supposedly unaware that he is making the noises happen-at least at the time they are occuring.

I would appreciate your take on this problem. How can I obtain the protections against problematic noise that I need and that are guaranteed by the city noise ordinance, so I can stay in my apt.
