#### **INFORMATION/UPCOMING BUSINESS**

##### **Class C Quota License Update**

*Senior Assistant City Attorney John Reiser provided an update on the Class C quota licenses allocated by Ann Arbor City Council on June 6, 2022. Reiser stated that of the eight allocated licenses, five of the eight licenses are in use. He provided status updates of the three licenses that are not currently in use:*

*-Jibarito A2, LLC at 309 S. Main St. was granted license approval by the MLCC on April 25, 2024. They have two years to begin using their license (by April 25, 2026).*

*-A2Wineman, LLC at 504-512 S. Main St. was granted license approval by the MLCC on August 1, 2023. They have two years to begin using their license (by August 1, 2025). The applicant needs to address pending permit matters with the Building Department.*

*-Chela's at 693 S. Maple Rd. is still in the application process. Communication from the applicant stated that they are committed to moving forward in their process, including providing requested documentation to the MLCC within the next two months. There are also potential matters to address with the Building Department.*

*Senior Assistant City Attorney John Reiser stated that he would work with Clerk's Office staff to draft a letter to Chela's regarding the status of their quota license.*
