Jennifer Lawson gave a power point presentation on the Traver Creek/Leslie Park Golf Course Streambank Stabilization Project.

- J. Lawson responded that the majority of the work would be done by the spring of 2013, with the goal of minimal golf disturbance.
- C. Smith added that the work will be staggered for least amount of disruptions on the course.

- J. Lawson said that the County is continuing to monitor the sediment situation.

- C. Smith explained that construction at Argo Bypass was complete for the winter season, with some minor work to be done in the springtime on the spillways, as well as paving of the paths, and the culverts and bridge work. He said the path is open and in good shape currently.

Smith stated that the City had received grants from the DNR for the Skate Park in Vet's Park as well as for Gallup Park and he thanked staff and the Friends of the Skate Park for their hard work on the submittal process. He said the next step will be to put out a detailed RFP for the design/build of the skate park.
