C-1 Resolution in Appreciation of Staff and Partners' Work on End of Year Closings

Commissioner Ezekiel said that December was a great month for the greenbelt. They had four properties closing that month. It was a big push because the tax laws were changing in January 2013 and farmers wanted the closings to happen quickly. The Commission honored some people who worked diligently to make those closings happen.

A motion was made by Commissioner Rubin, seconded by Commissioner Allen, that the Commission adopt the following resolution:

Resolution in recognition of the exceptional work by Mary Fales, Matt Keir, Roseanne Bloomer and Staff for the 2012 Land Acquisitions.

Whereas, Mary Fales is the Senior Assistant City Attorney for the City of Ann Arbor and provides legal counsel for the Greenbelt Land Acquisition deals;

Whereas, Matt Keir is Vice President of Liberty Title, the City's closing agent for land transactions;

Whereas, Roseanne Bloomer is a Lending Officer for Green Stone Farms Credit Services;

Whereas, Ginny Trocchio, provides staff services to the Greenbelt Program;

Whereas, The City of Ann Arbor's Greenbelt Program completed four transactions in the month of December 2012; and

Whereas, These transactions represent critical lands the Greenbelt Program identified as priorities and allowed the Greenbelt Program to surpass 4100 acres protected;

RESOLVED, That the Greenbelt Advisory Commission recognize Mary Fales for her exceptional legal counsel in relationship to greenbelt land transactions to ensure timely completion of conservation easements;

RESOLVED, That the Greenbelt Advisory Commission recognize Matt Keir for his exceptional service provided to the City of Ann Arbor's greenbelt for end of year closing;

RESOLVED, That the Greenbelt Advisory Commission recognize Rosanne Bloomer for expediting necessary documents for end of year closing;

RESOLVED, that the Greenbelt Advisory Commission recognize Ginny Trocchio for her service to the Greenbelt Program.

THE CONSERVATION FUND CONTRACT RENEWED

Ms. Trocchio said that City Council approved a renewal of their contract at their last meeting. She thanked Council for approving the contract and said that she was really please with continuing her work with the Commission and the City.

CHERRY REPUBLIC DONATION

Ms. Trocchio announced that Cherry Republic has made another donation to the greenbelt in the amount of \$5000.00. They also made a donation of \$2500.00 a couple of years ago. A portion of the Republic's profit is spent on contributing to farmland preservation in the areas where they have stores one of which is in Ann Arbor. They have also contributed to areas up North as well as the Glenn Arbor area where the home store is located.
