1. Jacqueline Beaudry - Legistar Presentation

Jacqueline Beaudry, Ann Arbor City Clerk, introduced Legistar to the commission. Legistar is the a new Legislative Information Center that the city uses to provide up-to-the-minute links to Agenda and Packet information, Boards and Commission members and more. NEW BUSINESS

1. 08-0359 Open Space and Parkland Preservation Millage and Bond Finances

Ginny Trocciho passed out information regarding the Millage and Bond Finances. The documents outlined the Millage Funds. The Parks Advisory Commission (PAC) and the Greenbelt Advisory Commission (GAC) requested that staff break down the funding available in the millage and what has been spent by both Commissions and what is remaining for future projects. Funds were divided between PAC and GAC with 2/3 of the money going to GAC for Land Acquisitions and 1/3 going to PAC for Land Acquisitions. The documents are only guiding principals at this time and have not been approved by City Council.

Damon Thompson, Financial Manager for the City of Ann Arbor, explained the Open Space and Parkland Preservation Millage and Bond Finances to the Commission. The draft is a historical summary of the millage and where the city stands between the Park Advisory Commission and the Greenbelt Advisory Commission. The draft mid-year income statement provides back up information regarding the summary of Open Space and Parkland Preservation document. As of February 29, 2008, there is a Fund balance of \$14,296,752.00 available for GAC and over all, a Fund balance of \$18,807,211.00 which shows \$4,510,458 for PAC. Copies of the Open Space and Parkland Preservation Millage and income statement for the Open Space and Parkland Preservation Millage drafts are on file in the City Clerk's Office.

Commissioner Hall asked why there was a 1/3 - 2/3 split regarding the joint PAC/GAC Administrative expenses instead of it being related to each of the commissions are spending. The administrative expenses are related to the project expenditures, but are split 1/3 - 2/3 which is not equal in any year to how much was going on with each commission.

Mr. Thompson said that this was done historically, but that he could do a reverse scenario back to actual acquisitions if the commission desired.

Ms. Trocchio said that there were also general expenses such as GIS which is GIS Staff that has spent time on the program as a whole and is not divided out into hours spent on Greenbelt or Pack, they are just general expenses.

Commissioner Ezekiel asked for clarification of the memo handed out relating to the calculation of the total revenue associated with each of the commissions.

Ms. Trocchio explained that it includes the projects, acquisitions and all of the administration costs.

Staff was asked to bring back dollar amounts associated with projects that are pending for each commission.

2. Landowner Donations

Commission Easthope said that he would like to have more landowner contributions to the Greenbelt. He explained that if appraisals come back more in line in what we think the market is now, there may be more leverage on behalf of the commission in terms of making offers on properties.

Commissioner Bloomer said that we are facing a psychological barrier as property values has been dropping. As the appraised values are dropping, there may be difficulty justifying donations. He said that it's easier to ask for donations when property values are going up rather than down.

The commission discussed the issue in more detail.

2. Offer to Landowners Identified in Application Number 2007-09

A motion was made by Commissioner Omenn, seconded by Commissioner Garfield, to recommend to Council to make an offer to the landowners identified in application number 2007-09 in the amount of \$4,004,000.00 contingent upon Ann Arbor Township's participation of 50% of the remaining purchase price (after grant funds) plus closing and due diligence costs be approved. On a voice vote, the Chairperson declared the motion carried.

Partner with Washtenaw County on the Properties Identified in Application Number 2007-18

A motion was made by Commissioner Omenn, seconded by Commissioner Ezekiel, to recommend to Council to partner with Washtenaw County on the properties identified in application number 2007-18 for up to 50% of the remaining purchase price, not to exceed a total of \$626,625.00 or (\$4,500.00/acre) be approved. On a voice vote, the Chairperson declared the motion carried.
