The Design Review Board discussed the design plan for the proposed 621 Church Street development project on May 15, 2024. The Design Review Board proposed the following comments and recommendations for this site plan application:

- 1. The simplicity of design and the vertical expression of red panels is much appreciated and keeping these features is encouraged as the design is refined. Be mindful, however, about the longevity of the exterior panel color and use materials or finishes that will not fade over time.
- 2. The street level experience, and especially the lobby entrance, is one of the strongest aspects of the design. Keeping these features is encouraged as the design is refined.
- 3. The alley should be designed as a primarily pedestrian, or nonmotorized, curbless space and vehicular use should be limited as an accessory function. Consider using pavers or other decorative material to promote the pedestrian-first design and encourage it becoming a covered, outdoor gathering space with occasional vehicle crossing.
- 4. The design for the top of the building and the flat façade are among the weakest aspects of the design. Adding more dimension, decreasing the monotony, is recommended as the project is refined.
- 5. If the corner parcel is included in the project, the corner treatment to the building needs to be a more prominent feature. If not, the projected wing should be removed from the design.
- F-2. Status of City Council Resolutions and Changes to Design Review Board

 Deputy Planning Manager Hank Kelley presented the proposed Council resolution.

The board discussed and agreed to continue the topic at the next regular meeting, and to forward a communication to City Council.

God rest his soul.
