# Call for projects: FY 2010 and FY 2011 safety program

SEMCOG and the Michigan Department of Transportation (MDOT) have issued a call for projects for fiscal year 2010 and FY 2011 safety programs. Safety funds are intended for highway safety improvements on the local road system. Eligible projects include, but are not limited to, guardrails, removal of fixed objects in clear zones, traffic signals, access management, curve corrections, sight distance and drainage improvements, bridge railing replacement or retrofit, midblock pedestrian crossings, improvements to school zones, intersection improvements for capacity and/or safety, rumble strips, and improved permanent signing and pavement markings. Federal funding of up to \$400,000 per project is available. A minimum 20 percent local share of project costs is

required. Only the construction phase is eligible for funding, except for certain limited circumstances.

Cities, villages, and road commissions are eligible to submit applications for safety projects, due to SEMCOG by February 27, 2009. SEMCOG continues to request that MDOT award at least one safety project to each county in the region and the City of Detroit. ### Workshop on February 20 to discuss \$20 million in Federal Assistance to protect Lake St. Clair

Over the last several years, significant water quality improvements have been made in the Lake St. Clair Watershed. A recent federal authorization of \$20 million could provide significant assistance to local governments in their efforts to protect Lake St. Clair. A workshop will be held on February 20, 2009, from 9-11 a.m., at the Macomb Intermediate School District (44001 Garfield, Room 103 A/B, Clinton Township), to discuss opportunities and alternatives for moving the \$20 million authorization to appropriation and to explain how the real-time drinking water monitoring system is working and how it can be used to efficiently allocate resources. There is no charge for the workshop, but registration is encouraged. #### Federal policy to aid foreclosure prevention

On January 21, 2009, the U.S. House of Representatives passed legislation to devote at least \$50 billion towards a plan to prevent and mitigate residential mortgage foreclosures. This bill, the TARP Reform and Accountability Act (H.R. 384), requires the Treasury Department to use a portion of the remaining \$350 billion in the Troubled Asset Relief Program (TARP) to help homeowners by improving the Hope for Homeowners program, assisting qualified home buyers obtain affordable mortgages rates, and providing incentives and assistance to servicers to modify or refinance existing loans. These provisions correspond with the recommendations of SEMCOG's Executive Committee of December 12, 2008. SEMCOG will continue to monitor this legislation and provide

### SEMCOG releases regional age forecast by school district

SEMCOG released regional forecast of population by age group by school district within Southeast Michigan for five-year increments from 2005 to 2035 to assist in school planning.

Based on SEMCOG's 2035 Forecast, Southeast Michigan will have 142,000 fewer school-age children (ages 5-17) in its seven intermediate school districts in 2015 than there were in 2005. While the region as a whole is expected to experience a reduction of 16 percent in its school age population, the rate of change varies significantly among individual school districts within the region. In the longer term, the region as a whole is expected to experience a modest growth of 24,000 children (or three percent gain) between 2015 and 2035.

# SEMCOG saves local governments money by coordinating joint purchase of stormwater video

SEMCOG is working to coordinate a joint purchase of a Stormwater Best Management Practices Training Video to assist local governments in meeting their Phase II permit requirements. The newly revised Michigan Department of Environmental Quality Phase II Stormwater Permits require all existing employees that work with stormwater to be trained once during the permit cycle on basic stormwater pollution prevention. In addition, all new employees must receive training within the first year of employment. Staff that view this Stormwater Training Video will help meet this requirement. The video has been previewed by several local

government staff with positive reviews (it can also be previewed for free at www.excalvisual.com/exvihome.pl).

The price of the Stormwater Training Video is \$495; however if 25 or more kits are ordered through SEMCOG, the cost to communities is \$297 (a cost savings of 40 percent). Contact: Angela Riess, SEMCOG Environment Planner.

### USDOT approves second border crossing for Southeast Michigan

The U.S. Department of Transportation (USDOT) has approved plans to build a second border crossing between Michigan and Ontario. A Record of Decision (ROD), signed January 14, 2009, represents the Detroit River International Crossing's (DRIC) final environmental clearance and allows Michigan to begin right-of-way acquisition and construction planning for the bridge.
