Facilitator Julia Novak, with City Administrator Howard Lazarus and the City leadership team, lead Council in a planning and priority session, as well as a presentation of upcoming budget and planning issues previously identified by staff.

Regarding 2016 priorities, the following was reported:

Accessory Dwelling Unit ordinance - complete

Allen Creek Greenway - in progress, expected completion FY18

Rebuild Forestry Program - in progress, developing work plans

Repair Roads - ongoing

Safe Systems for Auto, Pedestrians and Bike Users - approval of safe passing ordinance, inventory of assets completed, ongoing efforts for education, enforcement, encouragement and evaluation

Council identified the following new priority items for the upcoming year:

Implement Ann Arbor Climate Proposal

Implementation of Police Department Oversight Board

Develop Plan for City-owned Property in line with Sustainability Goals

Develop and Budget to Implement Affordable Housing Plan, Policy and Strategy

Study Impact of Income Tax

Improve Recycling Rates and Compost

PUBLIC COMMENT - GENERAL (3 MINUTES EACH)

John Godfrey, 2809 Brockman, expressed concern about the newly approved ADU ordinance, stating his neighbor was able to obtain a solar permit for his front yard, using this ordinance.

Stephanie Preston, member of A2 Safe Transport, spoke in opposition to pedestrian safety issues being folded into the City's Safe Systems priority. She urged Council to make pedestrian safety a separate priority.

Claire Duvernoy, member of A2 Safe Transport, thanked Council for making pedestrian safety a priority. She urged Council to implement quick fixes right away.

Grant Shafer, Pittsfield Township resident, suggested that Council reallocate the \$260,000 in the budget for deer management to the Police Department.

Eric Lipson, Rosewood Street, spoke about pedestrian safety and urged Council to look at the crosswalk at Edgewood and Stadium across from Pioneer High School. He thanked Council for the installation of the RRFBs at certain intersections.

Chris Hewitt, Seventh Street, spoke about safe streets and urged Council to keep pedestrian safety as a priority.

Kathy Griswold, A2 Safe Transport, urged Council to take quick actions regarding pedestrian safety and to make this a priority.

Sally Daniels, FAAWN, urged Council to postpone the funding of deer management initiatives, until pedestrian safety issues were fully funded.
