➤ Proposed Resolution on Immigration – The Commission discussed the proposed Resolution to Oppose Increased Immigration Enforcement and Support Immigrant Families and found they were in agreement with the spirit of the proposal. Having not seen the final draft of the resolution, it was agreed that they could not co-sponsor it or support it directly, but could publically support the spirit behind it. They will draft a narrative that supports the resolution in general terms and potentially take it to Council. The Commission also discussed the disruption to the City and how the people of the community have been subjected to ICE profiles.
