Good afternoon,

I want to express my strong support as an Ann Arbor resident for my understanding of what much of what "Chapter 120 Solicitation of Immigrant Status" is about- -the premise that the City of Ann Arbor should not be inquiring about community members' immigration status.

I do share the same concerns as many Ann Arbor residents attending the city council meeting tonight, though I'm unable to attend. The exceptions we are concerned about are flagged below.

I take great pride in living in a progressive city that stands on the side of those who need support- including, of course, undocumented immigrants. In the current political environment eyes will be on Ann Arbor to see if we take a strong stand, showing that the fear and bias perpetuated by the Trump administration will not change our city. I commend the mayor and city council for their work here, and support what you do, which is why I am trying to express my concerns in a way that will not disrupt your work. Please examine the wording below and consider ways to resolve the concerns of constituents like myself, who wish to work with you to ensure that our city will continue to protect all immigrants, regardless of status, in our community.

Exceptions.

. (a) *Solicitation of information concerning immigration status when performing public safety functions while assisting federal law enforcement in the investigation of a criminal or civil offense;"*

Being undocumented is considered a civil offense. So this exception would seem to allow our police to assist ICE in investigating whether someone in our community is undocumented.

The second exception I'm concerned about is the one which allows the police to ask about someone's immigration status when they are processing an arrested person.
