**Background**

During the spring of 2014, City Council directed Ann Arbor's City Administrator to report on the status of a partnership with the Washtenaw County Parks and Recreation Department, the University of Michigan, the Humane Society of Huron Valley and other interested parties to develop deer management information with the assistance of the Michigan Department of Natural Resources Wildlife Division. The directive from Council arose as a result of resident reports of deer damaging landscaping and concerns regarding vehicle/deer collisions and deer-borne diseases.

On Aug. 14, the City Administrator provided to City Council the requested report. The Deer Management Options Report, which is available [online](#), outlined the need to develop a community-endorsed deer management plan built upon community input and management options approved by the Michigan Department of Natural Resources Wildlife Division.

In November of this year, the Office of Community & Economic Development - in partnership with the Veteran's Affairs Ann Arbor Healthcare System, the Ann Arbor and Ypsilanti Housing Commissions, and the Washtenaw County Continuum of Care (CoC) Board - was selected to become a partner in the Zero: 2016 campaign to end both chronic and veteran's homelessness by the end of 2016.

The Campaign is being spearheaded by Community Solutions, a national non-profit focused on ending homelessness. Community Solutions will work intensively with Washtenaw County's Continuum of Care to meet the federal goals set by President Obama to end veteran homelessness by December 2015 and chronic homelessness by December 2016. These goals are outlined in the President's plan, "Opening Doors: Federal Strategic Plan to Prevent and End Homelessness," located at [USICH.gov](http://USICH.gov)<<http://USICH.gov>>.



Washtenaw County was selected along with sixty-nine other communities for Zero: 2016 through a nationally competitive process. Selected communities will receive technical assistance and training to accelerate their housing efforts through four focus areas: closing the research-to-practice gap, real-time data and performance management, local systems redesign, and local team and leadership development. Community Solutions will provide hands-on coaching and data tools, and will curate a national peer-to-peer learning network to accelerate innovation across communities.

The initiative will formally launch in January of 2015 during the national 2015 Homeless Point-in-Time (PIT) Count, during which local volunteers will hit area streets and shelters to enumerate the local homeless population. In addition to counting homeless individuals, Washtenaw County will integrate an evidence-based survey into that count to identify all its homeless residents and determine the best available resources and housing options to end their homelessness.

According to the 2013 PIT count, on a single night in January, Washtenaw County had 10 veterans and 57 people experiencing chronic homelessness on its streets, and an additional 51 homeless veterans and 59 chronically homeless individuals in emergency shelters and transitional housing programs. On January 28, 2015, the Washtenaw County CoC will conduct its next PIT count that includes outreach to those living on the streets and in shelters. The CoC Board and the community of providers that make up the CoC membership will be reaching out to community volunteers - including members of City Council and other elected and appointed officials - to assist in the PIT count and assessment process. OCED staff will pass along information to you as soon as it is available.

RULE 10 – Council Conduct of Discussion and Debate

Members shall not respond to member-distributed draft language via electronic communication. Members may send publicly-accessible electronic communications (e.g. Twitter posts).

As amended:

RULE 10 – Council Conduct of Discussion and Debate

● Electronic communication during Council meetings shall pertain only to City matters. During Council meetings, members shall not send private electronic communication to persons other than City Staff; provided however, that members may send draft motions, resolutions, and amendments to the City Clerk who will forward them to members of Council. Members shall not respond to member-distributed draft language via electronic communication. All draft language sent by electronic communication during Council meetings shall be read into the record prior to discussion by Council. Members will not send publicly-accessible electronic communications (e.g. Twitter and FacBook posts) during meetings.
