Vice-Chair Keeler reported that the sub-committee did meet last week and discussed concerns related City Hall parking. The sub-committee also discussed concerns related to a woman expressing her accessibility issues at Washtenaw Community College. Commissioner Hawkins reported that the Ann Arbor Inclusion is recording sessions this month. The organizations is planning to have monthly recording sessions. More information and details to come.

#### TRANSPORTATION COMMISSION UPDATE - LARRY KEELER

Vice-Chair Keeler reported that the Transportation Commission has been informed of the City Hall parking issue from the commission. The Transportation Commission will provide an update to Vice-Chair Keeler on the issue soon. Vice- Chair Keeler shared that the Transportation Commission is reviewing the commissions crash report. The Transportation Commission is also working to add separate bikeways downtown, automatic pedestrian signals, and creating two-way streets instead of one-way streets downtown. # U OF M COUNCIL FOR DISABILITY CONCERNS MEETING UPDATE - MATTHEW SOLOMON

Commissioner Solomon reported that the January 10, 2024 meeting of UM Council for Disability Concerns consisted of a series of brief disability-related updates and reports from the following disability partners: Feranmi Okanlami, Director of Student Accessibility and Accommodation Services (SAAS), Allison Kushner, ADA Coordinator for the University and Director for Disability Equity in ECRT; and Phil Deaton, ITS Accessibility team. Commissioner Solomon shared that the council discussed adaptive sports and fitness, with facts about adaptive sports curriculum adopted by the Ann Arbor public schools. The goal is to de-stigmatize disabilities by exposing 6th graders with and without disabilities to adaptive sports. In addition, future goals also include expanding the program from 6th grade to 7th and 8th grade in Ypsilanti Middle Schools. More information and details to come.

#### **ORGANIZATIONAL EQUITY - TRACY BYRD**

Tracy Byrd reported that she has started to take physical tours of the City's polling locations for accessibility. The polling locations are being reviewed for accessibility from a standpoint of public transportation. Tracy Byrd shared that the University of Michigan Center for Disability, Health and Wellness has a Disability Equity Book Club. The book club meets on monthly base. In addition, Tracy Byrd also reported that the City of Ann Arbor submitted an updated policy for the municipal foundation for employees. The policy is now streamlined and an interactive process. Tracy Byrd shared that in August of 2024 the Ann Arbor Area Transportation Authority (The Ride) bus route number 24 will no longer go all the way to Lake Transit Center.

### **CITY PERSONNEL REPORT - KENNEDI CUMMINGS**

Kennedi Cummings reported that the City of Ann Arbor has completed the search for a Police Chief. The City finalized the search for Police Chief candidates and Andrea Anderson has been named as the new Police Chief for the City of Ann Arbor. More information and updates for the new Police Chief start date to come. There is no additional city personal report or updates at this time.

#### **CHAIR REPORT - ZACH DAMON**

Chair Damon shared that the Ann Arbor Bicentennial kickoff celebration will be held this Friday, January 19 2024, from 6:00 P.M. - 8:00 P.M. at the Michigan Theater. All are welcomed to attend. The event has been completely sold out.
