# **Executive Committee meets on May 8**

SEMCOG's Executive Committee will meet on Thursday, May 8, 2008, at 1 p.m. in SEMCOG's downtown Detroit office. Action items to be considered are:

- approving amendment of the Ambassador Bridge Enhancement Project and Detroit River International Crossing (with conditions), and amendment of the Troy/Birmingham Intermodal Transit Facility, Woodward Avenue Light Rail Service, and Maple Road project to the 2030 Regional Transportation Plan for Southeast Michigan (RTP);
- approving an amendment to the FY 2008-2011
  Transportation Improvement Program, adding 118
  projects and deleting five projects (net amount of
  amendment is \$349.8 million);
- approving 22 projects as Southeast Michigan's submittal for the FY 2009 Safety Program (\$5.9 million);
- approving federal legislation that would appropriate funds in FY 2008 for redevelopment of abandoned and foreclosed homes and provide additional resources for housing counseling services for struggling borrowers; and
- approving a resolution regarding policy issues related to climate change.
