**WS-2 12-0331**

Budget: Fire and Other Service Area Budget Priorities

*Chuck Hubbard, Fire Chief, presented the proposed Fire Department budget to City Council. Chief Hubbard also outlined a new proposed staffing plan, which included the re-opening of Station 2 on Packard Road and the closure of Stations 3, 4 and 6 (Jackson Road, Briarwood, Huron Parkway). Tom Crawford, CFO, was available to answer questions related to the Fire Department proposed budget and Dale Berry, Huron Valley Ambulance CEO, was available to answer questions related to HVA ambulance transport service in the City. A copy of the presentation is on file in the City Clerk's Office.*

*Council inquired about the number of structure fires in the last year and whether this number represented an increase or decrease. The budget impacts were discussed and Council asked whether the new station plan could be "undone" if necessary. (City Administrator Powers noted that the closed stations would remain City property.) CFO Crawford noted that staffing levels could be maintained with the restructuring plan and the new contract approval.*

*Council took a short recess at 9:17 p.m. Councilmember Higgins left at 9:20 p.m. and Councilmember Teall left at 9:45 p.m.*

**WS-3 12-0329** Parks Millage Renewal

*Colin Smith, Parks and Recreation Services Manager, and Matt Warba, Interim Field Operations Manager, presented to Council information on the proposed Parks Millage Renewal. The millage renewal is proposed to be on the ballot in November 2012. A copy of the presentation is on file in the City Clerk's Office.*

*Mr. Smith noted that staff recommends keeping the general terms of the millage the same as the expiring millage to allow for a "renewal" versus a "new" millage.*
