In the past I have expressed my concerns to the Mayor who neither acknowledged nor responded. I live in Ward 2 next door to the Arb. I have long invested in replacing my landscape with native plants. We have had as many as six deer, at one time a 5 point buck, in our yard at a time. They walk down the middle of our road. My neighbor on the next street put a deer fence in which is useless. The lay out of our property makes it impossible to fence. The belief that the deer eat hosta but not native plants is a myth. Not only do they eat the native plants in my landscape but each year they eat more and different plants that are not part of their natural diet. They are hungry. I have seen a deer running down the sidewalk on Geddes past the cemetery at 8 o'clock in the morning when traffic is at its height. I have seen deer running across the bottom of Geddes Road where it curves and visibility is limited. Etc., etc. etc. Those who are against the cull might take a position that regardless of their impact we have to live with them rather than kill them. I might disagree but can't argue with that position. To perpetrate nonsense that anything short of a cull will solve the problem is untruthful. This community must accept the reality one way or another but be honest about it. It is the responsibility of the Council to educate the public about these realities.
