**1. Thomas Partridge - Integrate DDA/City, Greenbelt Funding Services and Re-Elect President Obama**

*Thomas Partridge, City resident, spoke about the re-election of President Obama and the need for more affordable housing in the City.*

**2. Alan Haber - Sustainability Goals (DC-8)**

*Alan Haber, 531 Third Street, spoke in support of the Sustainability Goals. He encouraged Council to include a public space in the downtown as part of the goals. He stated the community supports the development of the Library Lot as a public space.*

**3. Odile Hugonot-Haber - Sustainability Goals (DC-8)**

*Odile Haber, 531 Third Street, expressed concern about nuclear weapons. She provided Council with a copy of a statement supporting a nuclear free zone in the Middle East.*

**4. Kermit Schlansker - Cisterns**

*Kermit Schlansker, 2960 Marshall Street, spoke about the benefits of cisterns for energy conservation.*

**5. Linda Kurtz - Smart Meters**

*Linda Kurtz, 2150 Foss Court, spoke in opposition to smart meters. She expressed concern about the health risks associated with smart meters.*

**6. Carol Neylon - Smart Meters**

*Carol Neylon, 2021 Ferdon Road, spoke in opposition to smart meters. She expressed concerns regarding the health risks associated with smart meters, as well as concerns regarding security and privacy.*

**7. Bethanni Grecynski - Smart Meters**

*Bethanni Grecynski, 1423 N. Huron Street, spoke in opposition to smart meters. She stated while DTE has allowed for an "opt-out" to smart meters, the \$50 opt-out monthly charge is too expensive for most residents. Ms. Grecynski urged Council to do something to stop the installation due to the associated health risks.*

**8. Nancy Gerler - Smart Meters**

*Nancy Gerler, 1613 Dicken, spoke in opposition to the installation of smart meters. She urged Council to stop the installation, expressing concerns regarding health risks.*

**9. David Collins - City Park Regulations**

*David Collins, 730 Gott, expressed concerns regarding signage at Argo Cascades, which state that City Ordinance prohibits swimming in all waters adjacent to public land. He stated this is actually not legal. He urged Council to consider revising the signs and the ordinance to promote safety and warn would-be swimmers of the risks.*

**COMMUNICATIONS FROM COUNCIL**

COUNCILMEMBER SMITH

*Councilmember Smith stated there is a meeting of the North Main Street Task Force on July 11, 2012 at the NEW Center, 1100 N. Main.*

*The Fifth Avenue underground parking structure will be hosting a grand opening on July 12, 2012 at 5:00 p.m. The public is invited.*

*The Human Rights Commission is partnering with the Michigan Department of Civil Rights to testify on July 12, 2012 from 6:30 p.m. to 8:30 p.m. They are looking at adding new protected classes at the State level, including gender identity and sexual orientation.*

#### **COUNCILMEMBER BRIERE**

*Councilmember Briere reminded Council and the public that the Environmental Commission has vacancies. She said the commission will be considering new applications at their next meeting in July. Councilmember Briere also noted that the State of the Environment Report is now available on the City's website at [www.a2gov.org/soe](http://www.a2gov.org/soe)*

*Councilmember Briere reported on the Solid Waste Study Committee. She said the work is ongoing and a report is expected to be ready for Council in December. She stated there will be opportunities for public comment prior to the report being finalized.*

#### **COUNCILMEMBER LUMM**

*Councilmember Lumm stated she is working on a draft resolution for a Charter amendment regarding the voter approval for the use of parkland for any purpose other than for parks and recreation. She stated this resolution will be ready for Council at the July 16 meeting.*

#### **COUNCILMEMBER TAYLOR**

*Councilmember Taylor reported out on the Park Advisory Commission. He stated PAC has reviewed staff's draft resolution for a Charter amendment on the November ballot for the renewal of the Parks millage and affirmation of the existing administrative policies. He stated this resolution will be ready for Council approval at the next meeting in July.*

#### **COUNCILMEMBER ANGLIN**

*Councilmember Anglin noted that MDOT is hosting a public meeting regarding the Jackson Avenue lane conversion project. The meeting is scheduled for July 10, 2012 at 5:00 p.m. at Abbot School. Councilmember Anglin stated he still has concerns regarding this project.*

### **COMMUNICATIONS FROM THE CITY ADMINISTRATOR**

#### **NEW VOTER ID CARDS**

*City Administrator Steve Powers informed Council that the City Clerk had recently mailed all registered voters a new voter i.d. card. The new cards were sent to all*

voters due to changes to the City's US Congressional district following 2010 Census redistricting efforts. Locally, County Commissioner district numbers also changed. Mr. Powers noted that most voters did not have a change in assigned polling place.

#### VET'S POOL TEMPORARY CLOSURE

Mr. Powers noted that Vet's Park Pool is closed temporarily due to a pump failure. Staff is working on a repair to the pump.

#### TRASH COLLECTION SERVICES DELAYED

Mr. Powers informed Council and the public that trash collection would be delayed by one day beginning on Wednesday, July 4, due to the holiday. Trash and recycle collection would resume on Thursday, running through Saturday.
