SUBJECT: Resolution to recommend amending a Lease with Huron River Holdings, Inc. for Use of a Parking Lot at 416 Longshore Drive (\$11,750.00)

Attached for your review and action is a resolution to recommend amending a lease with Huron River Holdings, Inc. for use of the parking lots at 416 Longshore Drive. These parking lots has been used to accommodate parking needs at the Argo Livery since 2012. Use of these lots helps to reduce the amount of street parking in the neighborhood during the livery season by park users.

Terms of the lease allow the City to use the approximately 40 spaces in the west parking lot for park use only and used seven days per week, 9 a.m. to sunset. The additional 6 spaces in the west parking lot that are marked reserved and the approximately 12 spaces in the east parking lot will be available for park use on weekends and holidays only, providing additional parking for the Argo Park and Livery. The popularity of water recreation and the Cascades has resulted in the parking lot being used for overflow parking since the beginning of this lease. The lease before you reflects an increase in the annual payment from \$9,000.00 to \$11,750.00 per season. The term of this amended lease will be from April 18, 2019 - October 25, 2019 with an option to renew administratively for 3 successive 1-year periods, and additional years would include a \$250.00 per year increase.

The parking lot at 416 Longshore Drive provides up to an additional 58 parking spaces. It is expected that increased revenue from users fees will continue to help offset the cost of leasing the parking lot for the livery season. Funding is available in the approved FY2019 Parks & Recreation Services General Fund operating budget and will be contained annually in the Parks & Recreation Services General Fund for future years of the agreement.

Staff is recommending to amend this lease in the amount of \$11,750.00 for the first year, with each additional year including a \$250.00 increase.

Resolution to recommend amending a Lease with Huron River Holdings, Inc. for Use of a Parking Lot at 416 Longshore Drive (\$11,750.00)

Whereas, Argo Canoe Livery and Argo Cascades are used heavily due to the popularity of water recreation,

Whereas, The parking lot at 416 Longshore Drive provides up to 58 parking spots in close proximity to the Argo Livery;

Whereas, Demand for parking at the canoe livery is 7 days a week between April and October when the Livery is open;

Whereas, This parking lot has been used since the 2012 season and has assisted in helping meet parking demand;

Whereas, It is anticipated that increased revenue from users fees will help offset the cost of leasing the parking lot for the livery season; and

Whereas, Funding is available in the approved FY2019 Parks & Recreation Services General Fund operating budget;

RESOLVED, That Parks Advisory Commission recommend approval of amending a lease with Huron River Holdings, Inc. in the amount of \$11,750.00 for use of parking lot at 416 Longshore Drive for additional Argo Canoe Livery parking with an option to administratively renew for 3 successive 1-year periods.
