E. DISCUSSION ITEMS

E-1 <u>Eligibility of Surviving Spouse for Retiree Healthcare Coverage When Retiree</u> Had Waived Coverage at Retirement

Mr. VanOverbeke stated that this item has been placed on the agenda in order for Staff to receive clarification regarding a deceased retiree who, at the time of retirement was eligible for retiree healthcare, but had waived participation in order to receive healthcare with another employer. The retiree could have come back at any point in time if he didn't have other healthcare per the Plan provisions, and had he lived to draw that healthcare and passed away, because he elected an Option 2 benefit at the time of retirement, his surviving spouse would be eligible to receive the System's retiree healthcare benefits.

Mr. VanOverbeke stated that the question has been raised by the deceased retiree's spouse who is looking to retire and wants to know if she can participate in his healthcare at this point in time, and the answer to that is yes, that there is no provision in the Plan that penalizes someone for taking

the healthcare of the other employer. Had the retiree elected the straight-life option, she would not be eligible for the healthcare because an employee must elect an option form of benefit to be eligible. Mr. VanOverbeke stated that Human Resources may want to create a form which indicates the retiree's healthcare decision at the time of retirement. Ms. Walker stated that she would make that suggestion to HR.
