1. Staff Update

Ginny Trocchio, of The Conservation Fund, said that Shannon Brines has shown interest in applying to the commission. He is a local farmer in Webster Township and working at the U of M as a teacher. He said that the work that the committee is doing is important and that he has been a resident of Ann Arbor since 2002 and also has a small farm out in Dexter.

Ms. Trocchio said that Salem Township has been looking at passing a PDR Ordinance and allocating some of their general fund or landfill funds to PDR. Their board did approve the PDR Ordinance and allocated \$200k a year for farmland preservation for the next 5 years. They look forward to reaching out to them and working with them in the future.

The Commission asked that the map of Salem Township be forwarded to the commission so that the commission could see what properties have been placed in their protection zone. Ms. Trocchio said she was not sure if master plans changes were made, as the ordinance was just approved last night. She said she would provide more information to the commission at a later date.

Ms. Trocchio said that they talked about the expansion of the boundaries and this would be discussed more at the next GAC meeting. She plans to contact the commission over the next month to set up a time to do a tour for anyone who wants to see some of the proposed areas to be expanded.
