## SPECIAL PRESENTATIONS

### 1. Tomm Becker - Organic Farmer

*Tomm Becker presented his business plan for starting an organic Community Supported Agriculture (CSA) business in the Ann Arbor area, on a 15-acre lot of land that has applied to the Greenbelt for the Purchase of Development Rights. Tomm outlined his infrastructure needs for barns, hoop houses, and other buildings that would be needed for his business over the next 5 years. He plans on utilizing a small loan program to help build his first hoop house in August 2009. For the remainder of 2009 and winter of 2010, he is planning on doing some wholesale production of spinach, greens, and garlic for sale at local stores such as People's Food Co-op and Zingerman's. In 2010, he will begin his primary field production. He plans on producing on 6 out of the 10 acres of open field. He hopes to have a 100 member CSA in 5 years. Tomm answered questions from the Commission.*

## NEW BUSINESS

### 1. 09-0871 Appraiser's Proposal for Market Analysis

*Commissioner Allen presented a proposal to the Commission to conduct an analysis in Webster and Superior Townships on the number of available finished lots or semi-finished lots of converted farmland that are currently on the market. The purpose of the analysis would be to better understand the absorption rate, given the number of the lots currently available in these two townships in order to provide more detailed analysis of the market. The problem that appraisers are facing in conducting the appraisals is the out of date comparable sales available. The information may also be provided to appraisers. The analysis would be conducted by one of the appraisers that the Greenbelt has worked with, Mike Williams of the Gerald Alcock Company.*

**A motion was made by Commissioner Santi Hall, seconded by Commissioner Allen, to expend up to \$6570.00 to hire an appraiser to conduct a market analysis as detailed in the Scope of Work presented to the Greenbelt Advisory Commission July 8, 2009 in Webster and Superior Townships with the goal of studying the supply absorption pipeline of single family development conversion from farmland, to give the commission better information about fair market value of farmland and how we use this information will be determined at a later date. On a voice vote, the Chair declared the motion carried.**

### 2. Staff updates

*Ms. Trocchio stated that the City received a grant award from the USDA Farm and Ranchland Protection Program in the amount of \$1,030,050 for the Nixon farm in Webster Township. City Council approved accepting the grant funds on Monday, July 6, 2009.*
