RESOLVED, That the Ann Arbor Township Board and the Ann Arbor City Council find that there were 277 people residing in the annexed areas, and the ratio of population between the annexed areas being 277 persons, and the remainder of the Township as determined by the 2000 Census shall be the basis for determining the proper pro rata share for any state funds, monies or grants hereafter distributable under Michigan law.
