Statement of General Terms and Conditions

1. Fee Structure

All time including travel hours, spent on the project by professional, technical and clerical personnel will be billed. (Travel time and Travel expenses will not be billed to locations within our service area.) The following ranges of hourly rates for various categories of personnel are currently in effect:

| Category | Hourly Rate |
|----------------------|--------------------|
| Project Management | \$250 |
| System Engineering | \$200 |
| Service Engineering | \$175 |
| Research Technicians | \$100 |

Categories listed above are based on a typical project.

Unless otherwise stated, any cost estimate presented in a proposal is for budgetary purposes only, and is not a fixed price.

The client will be notified when 75 percent of any budget figure is reached, and the budget figure will not be exceeded without prior authorization from the client.

If after-hours work is necessary personnel will bill at time-and-one-half of their regular hourly rate. After-hours work will not be conducted without prior authorization from client.

2. Confidentiality

All communication and data between the client and AmeriNet Professional Services will be considered confidential. Outside vendors, manufacturers, service providers, carriers, businesses and other persons employed by the client will be considered by AmeriNet Professional Services to be authorized to be communicated with freely unless specifically noted by the client.

3. Agreement

The solution described in this document is based on APS's best understanding of the Customer's current computing/network environment, business and technical requirements. However, any inaccuracies or omissions in information provided to APS by the Customer or other parties may impact the project cost and/or schedule. Any changes to this document (such as a Job Change Order or an addendum due to an architectural design change) must be in writing. Such changes could also impact the project cost and/or schedule. Any timelines or dates in this document are best estimates only, and may change due to factors beyond APS's control.

4. Block Contracts

Blocks are intended to cover additional needs in support of an annual Service Agreement. Examples: Troubleshooting Non-contract Hardware, Configuration Changes, Upgrades. Hours must be used within 12 months of contract signing. After hours work is 1 ½ times the discounted rate. Weekend work is 2 times the discounted rate.
