- Mike Williams gave a slide presentation regarding a Market Study of the existing supply of single-family residential land within Superior and Webster Townships, with conclusion of its potential impact on future demand for developable land within the subject area. The analysis addressed statistical formulation of household growth, current level of sales activity within the subject area and categorizing of vacant land units between greenbelt and non-greenbelt areas. Resolution Regarding Purchase Price and Matching Funds for Greenbelt Purchases

**A motion was made by Commissioner Ezekiel, seconded by Commissioner Hohnke that the report be approved.**

*Ginny Trocchio passed out a spread sheet of all acquisitions to date, to the Commission. The spread sheet lists the completed acquisition projects and purchases approved by City Council with pending closings. She hoped that the spread sheet would help with the discussion regarding the resolution presented by Commissioner Hall. A copy of the spread sheet is on file in the City Clerk's Office.*

*Commissioner Bloomer said that he talked with Commissioner Hall regarding the proposed resolution. He created a letter to go along with the application, explaining exactly what is expected and what would happen to the application as it progresses. This letter was shared with Commissioner Hall, changes were made, and what is being presented tonight is the draft of that proposed letter.*

*Commissioner Bloomer further explained that after discussing it with Commissioner Hall, Commissioner Hall wanted to withdraw her original resolution and substitute it with the letter drafted by him.*

*Commissioner Ezekiel said that he talked with Commissioner Hall as well and he believed that she wanted to substitute the resolution with the letter.*

*Commissioner Omenn said that there were a lot of details in the draft resolution that could generate a lot of discussion. He suggested keeping the 2007 Resolution in place and writing a memorandum to potential applicants.*

*The Commission discussed the resolution regarding purchase price and matching funds for greenbelt purchases and the proposed Greenbelt Application Introduction letter that would be included with all future greenbelt applications in more detail.*

**A motion was made by Commissioner Omenn, seconded by Commissioner Ezekiel, that the Commission consider the draft letter presented by Commissioner Bloomer as a document that would enhance the communication with respective applicants and opportunities with the Greenbelt. On a voice vote, the Chair declared the motion carried.**

*Commissioner Rubin said that the letter focused on Purchase of Development Rights, property stays private. Many applicants that want natural areas where they do not want to retain the rights but rather make it to a fee simple sale. She thought that two applications may be needed given the third paragraph which talks about the preservation of land that is termed private property, not intended for parkland, that there are fact preserves and other applicants perceived where there is interest in public property.*

*Commissioner Bloomer said that there should be different applications for different purposes. This application would not be for developers or someone who wants to sell their land fee simple. He further explained that this letter was to clarify things for people who are offering their development rights. The reason for the paragraphs mentioned above were included was to explain the development rights to the applicants.*

*Ms. Trocchi said that currently there is only one application for all properties. There are questions on the application that the applicant would mark whether they are interested in Purchase of Development Rights or a Fee Simple purchase. However, they could create an application for Purchase of Development Rights and one for Fee Simple purchases with two different preambles.*

*After further discussion the Commission created a sub-committee to review the letter in more detail and create a second letter for the fee simple purchase and report its findings to the Commission in November.*

There were markets that advertised greenbelt farmers selling food and there was greenbelt branded food products that did not belong to the greenbelt company, just simply advertising and promoting greenbelt initiatives. He said that it was very interesting how they used it there in an initiative that is even younger than ours. There are a lot of other creative things they have done that the Commission may be able to learn from.*
