**1. Orian Zakai - Ann Arbor Housing Commission Minutes (I-2)**

*Orian Zakai, 220 N. First Street, #B3 addressed Council regarding the establishment of a 24-hour warming center, which would supplement the nighttime services currently provided by the Delonis Center. He stated a taskforce of interested community members has been created to look at this issue.*

**2. Arthur Endsley - Ann Arbor Housing Commission Minutes (I-2)**

*Arthur Endsley, 522 N. Division, #3, spoke in support of creating a community warming center, as more beds are needed. Mr. Endsley thanked Council for the additional \$25,000 in funding that was provided to the Delonis Center to support their small warming center this year, but stated much more is needed as the colder months are quickly approaching.*

**3. Thomas Partridge - Give the gift of Government integrity. Federal investigation of Government and business corruption needed. Bar discrimination in housing and transportation (I-2, I-3)**

*Thomas Partridge, Ann Arbor resident, addressed Council regarding government integrity, federal corruption and discrimination in housing and transportation.*

**4. Lourdes Salazar - - Ann Arbor Housing Commission Minutes (I-2)**

*Lourdes Salazar, 2145 Foss Ct., spoke to Council about her upcoming deportation back to Mexico. She explained that her husband has already been deported and her*

children are U.S. citizens. She asked for leniency to allow her to stay with her children. She asked Council to write to Immigration on her behalf.

**5. Lily Au - Ann Arbor Housing Commission Minutes (I-2)**

*Lily Au, 682 Peninsula Ct., spoke in support of the efforts of Occupy Ann Arbor to raise awareness regarding homelessness. She stated the current warming shelter does not have enough beds available for the current demand.*

**6. Laura Sanders - Ann Arbor Housing Commission Minutes (I-2)**

*Laura Sanders, 1718 Daniel St., on behalf of the Washtenaw Interfaith Coalition for Human Rights, asked Council to intervene and show public support on behalf of City residents, such as Ms. Salazar, who are facing deportation.*

**7. Ann Daws-Lazar - City-wide Police Dispatch Services by Washtenaw County (DS-2)**

*Anne Daws-Lazar, 3307 Turnberry, spoke in opposition to the proposed resolution regarding City-wide Dispatch Services by Washtenaw County. She said that the articles in Ann Arbor.com have indicated that Washtenaw County Dispatch is able to handle more calls with less people. She stated this is misleading, as the main reason that more calls have been handled through the system is due to the assistance of AAPD in the joint dispatch center.*

**8. Alan Haber - Littering and Distribution of Handbills Ordinance (C-1)**

*Alan Haber, 531 Third St., spoke in opposition to the proposed Littering and Distribution of Handbills Ordinance, stating that he was not clear on how a handbill would be defined and, if approved, how information could be legally distributed.*

**9. Danyelle Tucker - City-wide Police Dispatch Services by Washtenaw County (DS-2)**

*Danyelle Tucker, 5943 N. Harvey, Westland, MI, employee of the Ann Arbor Police Department, expressed concern with the proposed resolution regarding City-wide Police Dispatch Services by Washtenaw County. She stated that she will be losing her job as a result of the proposed lay-offs and expressed concerns regarding service quality for City residents, as a result of transferring this work to the County.*

**10. Kermit Schlansker - Sewage**

*Kermit Schlansker, 2960 Marshall, addressed Council regarding alternatives for energy, such as recycling sewage.*

**COMMUNICATIONS FROM COUNCIL**

*COUNCILMEMBER DEREZINSKI*

*Councilmember Derezinski announced that a meeting sponsored by the Southeast Michigan Council of Governments (SEMCOG) is scheduled to take place on December 13, 2011. The meeting will be held at the Mallett's Creek Library from 4:00-5:30 p.m. The discussion will focus on the region's economic development and future employment opportunities.*

**COUNCILMEMBER TEALL**

*Councilmember Teall updated the public regarding the Stadium Bridge reconstruction project. Due to the closure of State Street and the demolition of the bridge, discussions have taken place regarding traffic in the area. She thanked Mike Nearing of the City's Project Management team for his responsiveness to residents regarding traffic and other concerns related to the project.*

**COUNCILMEMBER ANGLIN**

*Councilmember Anglin responded to the public comments that were raised early in the meeting regarding immigration and immigrant rights. He urged Council to take a leadership role in the national discussion.*

**COMMUNICATIONS FROM THE CITY ADMINISTRATOR****INTERIM PUBLIC SERVICES AREA ADMINISTRATOR**

*City Administrator Steve Powers announced that Public Services Area Administrator Sue McCormick's last day is December 16, 2011. Craig Hupy, Field Operations Manager, will serve as Interim Public Services Administrator effective December 17, 2011. Mr. Powers noted that Mr. Hupy was not interested in the full-time position; he would only be serving on an interim basis until a permanent replacement is chosen.*

**BUDGET RETREAT**

*Mr. Powers asked Council to consider waiting on their annual budget retreat meeting until after the approval of the FY13 budget. This change in schedule would give Mr. Powers more time to prepare for the new 2-year budget cycle, since the FY13 budget is already planned as part of the current 2-year process. (City Council was agreeable to this change.)*

*Shoshana Hurand, 1206 Brooklyn, said that public art is an expression of the community's identity and culture and creates a sense of pride. She encouraged Council to continue funding at the current 1 percent level.*

*Mary Price, Ann Arbor resident, addressed Council about why public art matters.*

*Marsha Chamberlain, Chair of the Public Art Commission, encouraged Council to continue the current 1 percent funding level for public art.*

*An unidentified resident on State Street spoke in support of public art.*

*Alexandra Hoffman, University student, said that she was not opposed to public art, however, she urged residents to think about a warming shelter in the community as well.*

*A member of the audience asked if some of the public art funding could be used in a humanitarian effort to support the funding of a warming shelter.*

*Nancy Kaplan, City resident, suggested that the public weigh in on the percent for art program through a public vote. She suggested putting the issue on the November ballot.*

**COMMUNICATIONS FROM COUNCIL***COUNCILMEMBER BRIERE*

*Councilmember Briere said that the funding for public art cannot be repurposed for social service funding, such as the warming center that was mentioned during the public hearing. However, she encouraged those residents who were interested in funding a warming center to continue to develop new creative ideas.*

*COUNCILMEMBER KUNSELMAN*

*Councilmember Kunselman said that he thought there was an opportunity to use the Public Art Fund as some of the speakers had mentioned for other funding. 415 W. Washington is a capitol item that is publicly owned and improvements could include lighting and parking lot repair.*

*COUNCILMEMBER SMITH*

*Councilmember Smith noted that the fact that the homelessness issue and the public art ordinance are on the same agenda is more a matter of timing than it is of relevance. The City spends significantly more than one percent of capital improvement projects on housing and human services and will continue to do that to make sure the programs that are needed are covered, she said. Councilmember Smith stated that linking the funding of these two issues together and making it a choice is a mistake for both programs.*

*MAYOR HIEFTJE*

*Mayor Hieftje said that the 415 W. Washington property was being considered for a community arts center and greenway park. The largest hurdle is the condition of the 415 W. Washington building. The building is filled with asbestos and the plumbing may not be working. Mayor Hieftje noted that the greenway park presents less obstacles as the building itself would not be necessary for the park versus a public arts center that would require a rehabilitation of the building.*

...1:833.     **Art funding requirements for capital improvement projects.**  
Except as otherwise provided in this section, all capital improvement projects funded wholly or partly by the city shall include funds for public art equal to one percent (1%) of the construction costs identified in the initial project estimate, up to a maximum of \$250,000.00 per project[; provided that for the period July 1, 2012, through June 30, 2015, the percentage shall be reduced to and be one half percent (0.5%)]. Where a capital improvement project is only partly funded by the city, the amount of funds allocated for public art shall be one percent (1%) of that portion of the project that is city-funded, up to a maximum of \$250,000 per project[; provided that for the period July 1, 2012, through June 30, 2015, the percentage shall be reduced to and be one half percent (0.5%)]. All appropriations for capital improvements falling within the provisions of this chapter shall be deemed to include funding to implement the requirements of this subsection 1. ...

**(1) Funds for public art that are included as part of a capital improvement project or that are in a pooled public art fund may be used for the purposes**



identified in section 1:834.

(2) Funds for public art that are included as part of a capital improvement project or that are in a pooled public art fund also may be used to fund the administration of the city's public art program and projects, including staff time.

(3) Funds for public art that are included as part of a capital improvement project or that are part of a pooled public art fund may be not be transferred to any other fund, encumbered or utilized for any purpose except the purposes specifically set forth in this chapter.

(4) [Funds for public art that are placed in a pooled public art fund after July 1, 2012 that have not been disbursed or encumbered for an art project for three (3) full fiscal years shall be returned to the fund of origination, provided that Council may extend the foregoing period by resolution for successive periods, each not to exceed six (6) months.]

[(5)] Contracts, including but not limited to those for the creation, production, purchase or other acquisition of public art, and to install, maintain, alter, repair, refurbish, relocate or remove public art, shall be processed and approved in accordance with all applicable city requirements.
