**WS-1 [11-0754](#) 2010 Census - City Ward Reapportionment Plan**

*City Clerk Jacqueline Beaudry presented to Council proposed changes to the City ward boundaries due to population shifts that were noted in the release of the 2010 Census numbers.*

**WS-2 [11-0738](#) Street Millage Renewal (Project Management)**

*Homayoon Pirooz, Project Management Manager, presented to Council plans for a public outreach campaign regarding the upcoming street repair millage renewal. One option for the renewal effort is to raise the millage from 2.0 mils to 2.125 and include funding for the sidewalk repair program.*

*Councilmembers requested that staff include a slide in the public presentation that explained the current fund balance and future projects.*

*A list of proposed streets for the 2012-2013 program was also requested.*

**WS-3 [11-0750](#) Annexation of Township Parcels**

*Sue McCormick, Public Services Administrator; Cresson Sloten, Systems Planning Manager; and Jeff Kahan, City Planner; presented information to Council regarding the remaining parcels of township islands within the City and the plans for future annexation of these parcels. Discussion included the availability of city services and the need for city water and sewer in some cases.*
