He also expressed concern about the game-day restriction, stating Michigan football games are a high visibility day for him and help him get reservations for the rest of the year.*

Resolution to Approve New Fees for Commercial Quadricycle Operating Permit

**Sponsors:** Council Liquor License Review Committee

*Assistant City Attorney Mary Fales introduced the proposed resolution to set the Commercial Quadricycle fees. A copy of other Michigan fees was also provided. City staff stated the proposed fee of \$145.00 included cost recovery for staff time and materials.*

*The Committee also discussed the required signage needed to enforce the ordinance in the downtown.*

**UNFINISHED BUSINESS**

Discussion of Commercial Quadricycle Ordinance (currently in 2nd Reading at City Council)

*The committee discussed the quadricycle ordinance that was currently before City Council at Second Reading. Issues raised by City Council included the requirement for seatbelts and whether a ban on alcohol on the quadricycle was necessary.*

*Lt. Bush stated the Police do not enforce seatbelts currently on bicycles. It was also noted that some of the quadricycles have bar stool-type seats and a seatbelt really wouldn't work well.*

*Councilmember Smith expressed concern that the Committee was making an issue out of something that wasn't a problem currently.*

*Councilmember Ackerman moved, seconded by Councilmember Kailasapathy, that the Council Liquor License Review Committee recommend to Council that the requirement in Section 10, 2:141F, regarding seatbelts be removed.*

*On a voice vote, the motion carried.*

*Regarding allowing passengers to bring alcohol on the quadricycle, Lt. Bush stated the Police Department is recommending a prohibition.*

*Councilmember Lumm requested that a representative from the Police Department be available at City Council to answer questions.*
