Dear City Council Members:

As you are aware, this law firm represents the Crossings of Ann Arbor Condominium Association (“Association”). On December 5, 2017, this firm submitted a letter to the Ann Arbor City Council (“Council”) outlining the City’s arbitrary and unlawful exclusion of the Association’s residents from eligibility for parking permits within the Northside Parking RPP District.

To date, this firm has not received any response from the City to address the Association’s concerns. To reiterate, the Association is requesting the City’s cooperation in proposing and adopting a resolution that amends the Northside Parking RPP District in a manner that affords its residents their fair and equal access to the RPP program. The Association is motivated to resolve this matter expeditiously so that its residents are no longer arbitrarily excluded from the RPP program and are given proper access to parking permits for the coming season.
