The Sensory Garden was able to purchase new plants from the Farmer's Market for the garden, but they have unfortunately been disrupted by rabbits. S. Petersen asked for any suggestions from the commission on how to further prevent rabbits, as the Sensory Garden is currently working on a solution with the City.

c COMMUNITY ENGAGEMENT COMMITTEE - AL BLIXT

A. Blixt gave an update on how the latest State budget will be affecting disability services. The community engagement committee will be discussing this further at their next meeting. The committee will not be meeting in July or August.

d PARTNERS IN ACCESS COMMITTEE - ALISON STROUD

The Partners in Access Committee has been discussing the current issue with parking and accessibility as it relates to the new ePark kiosk machines in Ann Arbor. They are hoping to schedule a meeting with the Downtown Development Authority to discuss current concerns and suggestions for the accessibility surrounding the locations of these kiosks. A. Stroud also gave an update on the SnowBuddies program, and what the Partners in Access committee will be doing to make sure that everything is all set before the first heavy snowfall of the year.

K. Westphal mentioned that an app for the parking kiosks is in the works, as cited by a recent Ann Arbor News article. He encourages the commission to continue discussing the accessibility of the physical kiosks.
