

Dear ,

Now is the time to make a lasting and impactful policy change to improve public health in Ann Arbor!

Despite recent progress in reducing tobacco use in the U.S., the rate of smoking has actually increased in Washtenaw County over the past year. The devastating effects of cigarette smoking are clear. That is why I am asking you to support the Tobacco21 ordinance and make it a law in Ann Arbor.

The ages of 18-21 are a crucial period, in which tobacco interest goes from experimental to daily and habit-forming use; 95 percent of current smokers report that they started using tobacco before age 21. If young people can reach the age of 21 as non-smokers they—almost certainly—never will become smokers. Raising the minimum legal age for tobacco could also have dramatic positive impacts for public health, reduce the cost for chronic, smoking-related illnesses, and save countless lives.



Good evening Mayor and Council Members

I am Lynn Borset, and I'm here to speak about the Library Lot Resolution you will vote on tonight.

I sent you an email on July 31st that contained data about those voters who signed the petition to put the Library Lot question on the ballot.

I know you received that email because several of you replied to me, and I thank you.

Three of the replies I received talked, not about putting this question on the ballot, but about why the Library Lot should not be an urban park used for public events in the Center of our City. A major reason given in each of these replies was that the Parks budget could not support construction, maintenance, and programming costs for the Library Lot without having a negative impact on our other parks.

Yet, before you tonight is a proposal to build an event space in our Farmer's Market and pay for it out of the Parks Budget. I believe the cost is \$350,000 and the term 'fund balance' is used.

Isn't that rather disingenuous? Do you see the inconsistency?

But back to the Library Lot Resolution. Please don't obscure the question of putting it on the ballot by confounding it with the same old rhetoric of why some of you don't want a community commons in the Center of the City.

The Library Lot Resolution tonight is about democracy. It is about listening to your constituents, more than 5% of whom want the right to vote on this in November. This is pretty unique, and it is significant.

The data shows you that voters from all Wards in the City signed the petition, and that all age groups, from 18 to 90 years of age, are represented. Significantly 27.4% of the signers are under 40 years of age.

Tonight you have the opportunity to listen to your constituents and pass the Resolution to put this on the November ballot.
