Mayor Hieftje called the Working Session of the Ann Arbor City Council to order at 6:00 p.m.

WS-1 Public Services Area Budget Presentation

Sue McCormick, Public Services Area Administrator, spoke to Council regarding street lighting, assessment districts, park maintenance, lawn moving, and the elimination of curbside leaf pickup. She also spoke about outsourcing composting.

Mayor Hieftje called a break in the meeting from 8:05 p.m. until 8:20 p.m.

Councilmember Kunselman stated that he opposed the privatization of the City's composting operation.

Councilmember Smith requested a list of non-profits who are now being charged for solid waste pickup.

Councilmember Kunselman asked why municipal service charges were increasing in solid waste funds.

Mayor Hieftje requested municipal service charge breakdowns for water and solid waste funds.
