Dear Stephanie,

Thank you for passing along these reports and concerns and recommendations for improving safety at the Fuller Road crosswalk. Your and your A2Safe Transport Team's observations of cars traveling too fast within the school zone, cars passing pedestrians/bicyclists w/in the crosswalk, and the inoperable street light (also reported through A2 Fix It and to DTE), are indeed very concerning, and clearly there is at this location and elsewhere, as you recommend, an urgent need for better education, enforcement and additional engineering improvements (traffic calming, RRFB's, etc.).

I will follow-up w/staff to further explore and assess the cost and needed next steps and timing for installing an RRFB at this location. I am also hopeful that the light will be repaired expeditiously, and we can redeploy officers while the light is inoperable. Your idea of speed monitoring and enforcement is also a helpful suggestion I'm hopeful the AAPD will pursue.

Thank you, again, for all your and your team's efforts to bring these safety concerns and needed improvements to the City's attention.

Hello,

I am passing on the report of a neighbor (below), who personally witnessed a near pedestrian crash on Fuller INSIDE the crosswalk.

As we are repeatedly seeing (and reporting to the city)--and as we described with data from hundreds of people in our A2SafeTransport report--**cars don't understand that people are crossing in these crosswalks and so they speed around stopped cars, greatly endangering the lives of people in the crosswalk** who are already crossing.

This is the **third report of a problem for students at this Huron crosswalk in just two weeks:**

- One person already contacted you to report that even with the street light at the mid-block park crossing she could not see two bikes trying to enter the crosswalk as she drove past.
- Now the light is reportedly not even working this morning at the mid-block park crossing, which we worked so hard to get.
- Plus, the witnessing below of the car speeding around the stopped car almost into the person crossing in the crosswalk.

**Traffic calming is needed with salient enforcement** for people who still think this is a great speedway/thoroughfare to the University or Hospital from far flung regions.

What about a sting operation twice a month for a few months during morning rush hour until the word gets out? (And even then randomly every other month or so to keep the memory fresh.) People love to gossip about sting operations, which is how word spreads rapidly by word of mouth. People particularly notice the type where one officer points at people who cross the person in the crosswalk or are speeding and then they are flagged over to the side where another officer gives the tickets to the people lined up. Pays for itself, generates buzz, impossible to miss.

I don't even think a crossing guard would be safe on Fuller at the speeds people are going, with their poor level of awareness of crosswalks and speed zones--they would be in danger at that spot. The temporary A2 officer was himself almost hit in the crosswalk and he was in uniform with a patrol car nearby.

I think there are **strong reasons to assume a flashing light activated by the walker is needed** at the mid-block crossing.

Either way, **education and enforcement are needed.**

We really **need the TSC to be more active in identifying problems at each school, which they report to the city and demand fixes.** It shouldn't be the job of citizens to point out danger and mistakes.

Every day the city drags its feet, and hires more consultants to study things that are already patently obvious, people are at risk.

Hi Stephanie,

Just picked up Catherine at Huron and witnessed another almost pedestrian accident at the Fuller crosswalk. Let me describe:

1. I was waiting in my car just North of the crosswalk, heading east on Fuller in order to move into the right turn lane (to get onto Huron Parkway South). This point is just before the driveway access to Gallup Park and the solid white line denoting the space next to the thru lane is not a right turn lane yet.
2. As the light turned green at Huron Pkwy and Fuller, a girl began crossing in the Fuller crosswalk from Huron to the park side.
3. A car in back of me, but slightly on the right (as they seemed to be in a hurry to turn right at the light), pulled around me quickly and drove into the crosswalk just as the girl reached the front of my car.
4. I blew the horn as hard as I could, but the car did not stop and almost hit her.

The point: The crosswalk needs flashing lights if these aren't already in the works AND the space next to the single east bound lane needs to be made smaller so cars can't fit to go around cars that are waiting in the thru lane or the space should be blocked somehow. The person behind me clearly could not see the girl crossing.

Could you please send this on to the planners? Please let me know if you are not the correct person to contact.

Let me know if you are interested in carpooling to Huron next year. I still am too paranoid to let Catherine walk.....
